A BILL

To establish the Virgin Islands of the United States
Centennial Commission.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Virgin Islands of the
5 United States Centennial Commission Act”.

6 **SEC. 2. DEFINITIONS.**

7 For purposes of this Act, the term “State” means
8 each of the several States, the District of Columbia, each

1 territory or possession of the United States, and each fed-
2 erally recognized Indian tribe.

3 **SEC. 3. ESTABLISHMENT.**

4 There is established a commission to be known as the
5 “Virgin Islands of the United States Centennial Commis-
6 sion” (in this Act referred to as the “Commission”).

7 **SEC. 4. DUTIES OF COMMISSION.**

8 The Commission shall—

9 (1) plan, develop, and carry out such activities
10 as the Commission considers fitting and proper to
11 commemorate the 100th anniversary of the Virgin
12 Islands of the United States becoming an unincor-
13 porated territory of the United States;

14 (2) provide advice and assistance to Federal,
15 State, and local governmental agencies, as well as
16 civic groups to carry out activities to commemorate
17 the 100th anniversary of the Virgin Islands of the
18 United States becoming an unincorporated territory
19 of the United States;

20 (3) submit to the President and Congress re-
21 ports pursuant to section 8.

22 **SEC. 5. MEMBERSHIP.**

23 (a) **NUMBER AND APPOINTMENT.**—The Commission
24 shall be composed of 8 members as follows:

1 (1) The Assistant Secretary of the Interior for
2 Insular Affairs or his designee.

3 (2) One member appointed by the Governor of
4 the Virgin Islands of the United States or his des-
5 ignee.

6 (3) Two Members of the House of Representa-
7 tives appointed by the Speaker of the House of Rep-
8 resentatives.

9 (4) One Member of the House of Representa-
10 tives appointed by the minority leader of the House
11 of Representatives.

12 (5) Two Members of the Senate appointed by
13 the majority leader of the Senate.

14 (6) One Member of the Senate appointed by the
15 minority leader of the Senate.

16 (b) ALTERNATIVE APPOINTMENT.—If the Governor
17 of the Virgin Islands of the United States or his designee
18 declines to make such appointment under subsection
19 (a)(2), such member shall be appointed by the Delegate
20 of the Virgin Islands of the United States.

21 (c) TERMS.—Each member of the Commission shall
22 be appointed for the life of the Commission.

23 (d) DEADLINE FOR APPOINTMENT.—All members of
24 the Commission shall be appointed not later than 90 days
25 after the date of the enactment of this Act.

1 (c) VACANCIES.—A vacancy on the Commission
2 shall—

3 (1) not affect the powers of the Commission;
4 and
5 (2) be filled in the manner in which the original
6 appointment was made.

7 (f) RATES OF PAY.—Members shall not receive com-
8 pensation for the performance of their duties on behalf
9 of the Commission.

10 (g) TRAVEL EXPENSES.—Each member of the Com-
11 mission shall be reimbursed for travel and per diem in lieu
12 of subsistence expenses during the performance of duties
13 of the Commission while away from home or his or her
14 regular place of business, in accordance with applicable
15 provisions under subchapter I of chapter 57 of title 5,
16 United States Code.

17 (h) QUORUM.—A majority of the members of the
18 Commission shall constitute a quorum to conduct busi-
19 ness, but two or more members may hold hearings.

20 (i) CHAIRPERSON.—The chairperson of the Commis-
21 sion shall be selected by the Delegate of the United States
22 Virgin Islands.

23 **SEC. 6. DIRECTOR AND STAFF OF COMMISSION.**

24 (a) DIRECTOR AND STAFF.—The Commission shall
25 appoint an executive director considering the recommenda-

1 tion of the Delegate of the Virgin Islands of the United
2 States, and shall appoint such other additional personnel
3 as are necessary to enable the Commission to perform its
4 duties.

5 (b) APPLICABILITY OF CERTAIN CIVIL SERVICE
6 LAWS.—The executive director and staff of the Commis-
7 sion may be appointed without regard to the provisions
8 of title 5, United States Code, governing appointments in
9 the competitive service, and may be paid without regard
10 to the provisions of chapter 51 and subchapter III of chap-
11 ter 53 of such title relating to classification and General
12 Schedule pay rates, except that the rate of pay for the
13 executive director and other staff may not exceed the rate
14 payable for level III of the Executive Schedule under sec-
15 tion 5316 of such title.

16 (c) DETAIL OF FEDERAL EMPLOYEES.—Upon re-
17 quest of the Commission, the Secretary of the Interior or
18 the Archivist of the United States may detail, on a reim-
19 bursable basis, any of the personnel of that department
20 or agency to the Commission to assist it in carrying out
21 its duties under this Act.

22 (d) EXPERTS AND CONSULTANTS.—The Commission
23 may procure such temporary and intermittent services
24 from experts and consultants as are necessary to enable
25 the Commission to perform its duties.

1 (e) VOLUNTEER AND UNCOMPENSATED SERVICES.—
2 Notwithstanding section 1342 of title 31, United States
3 Code, the Commission may accept and use voluntary and
4 uncompensated services as the Commission determines
5 necessary.

6 **SEC. 7. POWERS OF COMMISSION.**

7 (a) HEARINGS.—The Commission may, for the pur-
8 pose of carrying out this Act, hold hearings, sit and act
9 at times and places, take testimony, and receive evidence
10 as the Commission considers appropriate.

11 (b) MAILS.—The Commission may use the United
12 States mails in the same manner and under the same con-
13 ditions as other departments and agencies of the United
14 States.

15 (c) OBTAINING OFFICIAL DATA.—The Commission
16 may secure directly from any department or agency of the
17 United States information necessary to enable it to carry
18 out its duties under this Act. Upon request of the chair-
19 person of the Commission, the head of that department
20 or agency shall furnish that information to the Commis-
21 sion.

22 (d) GIFTS, BEQUESTS, DEVISES.—The Commission
23 may solicit, accept, use, and dispose of gifts, bequests, or
24 devises of money, services, or property, both real and per-
25 sonal, for the purpose of aiding or facilitating its work.

1 (c) AVAILABLE SPACE.—Upon the request of the
2 Commission, the Administrator of General Services shall
3 make available to the Commission, at a normal rental rate
4 for Federal agencies, such assistance and facilities as may
5 be necessary for the Commission to carry out its duties
6 under this Act.

7 (f) CONTRACT AUTHORITY.—The Commission may
8 enter into contracts with and compensate government and
9 private agencies or persons to enable the Commission to
10 discharge its duties under this Act.

11 **SEC. 8. REPORTS.**

12 (a) ANNUAL REPORTS.—The Commission shall sub-
13 mit to the President and the Congress annual reports on
14 the activities of the Commission as well as the revenue
15 and expenditures of the Commission, including a list of
16 each gift, bequest, or devise to the Commission with a
17 value of more than \$250, together with the identity of the
18 donor of each gift, bequest, or devise.

19 (b) FINAL REPORT.—Not later than January 31,
20 2018, the Commission shall submit a final report to the
21 President and the Congress containing—

- 22 (1) a summary of the activities of the Commis-
23 sion; and
24 (2) a final accounting of funds received and ex-
25 pended by the Commission.

1 **SEC. 9. TERMINATION.**

2 The Commission may terminate on such date as the
3 Commission may determine after it submits its final re-
4 port under section 8(b), but not later than September 30,
5 2018.

6 **SEC. 10. ANNUAL AUDIT.**

7 The Inspector General of the Department of the Inte-
8 rior may perform an audit of the Commission, shall make
9 the results of any audit performed available to the public,
10 and shall transmit such results to the Committee on Over-
11 sight and Government Reform of the House of Represent-
12 atives and the Committee on Homeland Security and Gov-
13 ernmental Affairs of the Senate.
