**Bill No. 32-0341** – An Act approving the proposed sale of unit No. 3012, Building L in a group of buildings known as Cowpet Beach Resort, located on Parcels No. 8-1-11 Estate Nazareth, No. 1 Red Hook Quarter, St. Thomas, Virgin Islands

#### **CONSIDERATION OF BILLS:**

**Bill No. 32-0327** - “An Act benefitting especially Senior Citizens of the Virgin Islands amending the Virgin Islands amending the Virgin Islands Code Title 15, Chapter 13 and adding Chapter 60; and amending Title 28, to enact to Uniform Non probate Transfer Act, the Uniform Transfer on Death Act; the Uniform Disclaimer of Property Interest Act, the Uniform Custodial Trust Act; and the Uniform Partition of Heirs Property Act

**Bill No. 32-0241** - “An Act amending Title 23 of the Virgin Islands Code, Chapter 10, Sections 1006 and 1007, relating to the Virgin Islands Emergency Management Plan and the Virgin Islands Territorial Management and Homeland Security Council”

**Bill No. 32-0247** - “An Act amending Titles 3,5,14,15,16,19,23 27, and 34 to change all references to mental health to behavioral health; amending Title 19, Chapter 31, Section 716(A) relating to the Citizens Council on Mental Illness Alcoholism and Drug Dependency; repealing Section 14 of Act No. 7897 and Section 2, paragraph (1) of Act No. 7697; appropriating \$3,000,000 for the establishment of a behavioral health care facility on the island of St. Croix; and establishing requirements for the operation of in-patient and out-patient treatment programs at the behavioral health care facility

**Bill No. 32-0256** – An Act amending Title 9 Virgin Islands Code, adding chapter 25 enacting the Finance Lenders Law

**Bill No. 32-0308** – An Act amending title 3, Virgin Islands Code, chapter 19 adding sections 339, 339a, and 339b, to establish the Division of Festivals within the Department of Tourism whose function is organizing and executing festivals and to re-establish the Virgin Islands Cultural Heritage Institute within the Department of Tourism, title 33 Virgin Islands Code, subtitle 3, chapter 111, section 3088 to re-name the “Carnival ad Festival Committee Revolving

Fund” as the Division of Festivals Revolving Fund”, and title 3 Virgin Islands Code, chapter 22 by repealing section 408

**Bill No. 32-0204** - “An act amending Title 12 of the Virgin Islands Code, Chapter 16A, Section 691a by re-defining the term “government agency” and by defining the term "communications provider”, and section 698a regarding the construction of conduits by government agencies in the public rights-of-way and for other related purposes ”

**Bill No. 32-0229** - “An Act amending Title 23 of the Virgin Islands Code, Chapter 10, Subchapter 1, Section 1004 requiring the Government of the Virgin Islands to enter into contracts before June 1 of each year in preparedness for hurricane season or any emergency or major disaster”

**Bill No. 32-0062** – An Act amending title 12 of the Virgin Island Code, by adding a chapter 3A establishing the Community and Heritage Tree Law of the Virgin Islands

**Bill No. 32-0135** – An Act amending Title 19 of the Virgin Islands code, to add a Chapter 34 establishing “The Virgin Islands Medical Cannabis Patient Care Act” as it relates to the Medical Use and Regulation of Cannabis, the regulation of Medicinal Cannabis Provisioning Centers, and other related purposes

**Bill No. 32-0345** - An Act amending title 27 Virgin Islands Code chapter, 1 sections 5 and 34 relating to physician licensure and applicant qualifications
