



***THE FOLLOWING BILLS WERE INTRODUCED AND ASSIGNED BY THE
PRESIDENT IN PRO FORMA SESSION ON MAY 24, 2017***

Bill No. 32-0095 - An Act authorizing the Government Employees Retirement System to use certain unencumbered government property as additional collateral to secure pension revenue bond funding

(Assigned to the Comte. on Finance)***

Bill No. 32-0096 - An Act Amending Title 29 Virgin Islands Code, Chapter 12, Subchapter I, Sections 703, 710 and 712 relating to the employment requirements of residents under the Economic Development Program

***Proposed by Senators: Neville A. James and Sammuell Sanes
(Assigned to the Comte on Economic Development, and Agriculture)***

Bill No. 32-0097 - An Act repealing Section 116, 117 and 118 of Title 18 Virgin Islands Code, Chapter 5, relating to registration of electors to bar cancellation of voter registration in every instance other than death

Bill No. 32-0098 - An Act amending Title 33 Virgin Islands Code, Chapter 89, Subchapter III, Section 2541 pertaining to the attachment and sale of property for nonpayment of taxes

Bill No. 32-0099 - A Resolution honoring and commending Nels Hawkinson for founding the Paradise Jam in the Virgin Islands and exposing the territory to millions of Americans throughout the United States and the Caribbean

(Assigned to the Comte. on Workforce Development, Consumer Affairs, and Culture)***

Bill No. 32-0100 – An Act amending Title 27 Virgin Islands Code, Chapter 1, Subchapter II, Section 39, to require doctors and physicians to disclose any financial ownership or interest in any medical laboratory within or outside the Virgin Islands and from referring patients to a laboratory in which they have a financial interest

Bill No. 32-0101 - An Act appropriating \$100,000 from the Tourism Advertising Revolving Fund to Calypso, Inc. for continuing musical education for the youth of the Virgin Islands

Bill No. 32-0102- An Act to repeal provisions that allow persons who are receiving a retirement annuity from the Government Employees’ Retirement System to return to work for the Government of the Virgin Islands without making contributions to the GERS

Bill No. 32-0103 - An Act amending Title 14 Virgin Islands Code, Chapter 45, Section 923 (a) relating to imprisonment of minors for first degree murder

Bill No. 32-0104 – An Act to conduct a feasibility study on the implementation of a composting program in the Virgin Islands

Bill No. 32-0105 - A Resolution petitioning the United States Congress to offer full care medical services in the Virgin Islands for veterans living in the Virgin Islands

Bill No. 32-0106 - An Act amending Title 12 Virgin Islands Code, Sections 1143 (d) (2) and 1152 (a), as amended by Act No. 7705, relating to the definition of net metering and correcting an erroneous cross-reference citation; and repealing Section 1149, as added by Act No. 7705, relating to the expiration date for residential customer generators having a generating capacity greater than 10 Kilowatts

Bill No. 32-0107 - An Act authorizing the Department of Property and Procurement to conduct feasibility and cost studies on the sale of Government owned properties to raise revenues for the Government of the Virgin Islands

(Assigned to the Comte. on Government Affairs, Veterans, Energy, and Environmental Protection)*

Bill No. 32-0108 - An Act to conduct a feasibility study on the construction of a gas station which would be wholly owned and operated by the Government of the Virgin Islands

Bill No. 32-0109 - An Act providing for property tax benefits for retirees on the Government Employees Retirement System who are owed retroactive wages

Bill No. 32-0110 - An Act providing for a Referendum vote on the issue of whether an Electric Cooperative should be established in the Virgin Islands

Bill No. 32-0111 - An Act to amend Title 1 Virgin Islands Code, Chapter 11 to establish September as Virgin Islands Prostate Cancer Awareness Month and to require an annual proclamation by the Governor
