An act ratifying the Governor's approval of the Modification and Extension of Consolidated Major Coastal Zone Management Permit Nos. CZJ-04-14 (W) and CZJ-03-14 (L)

PROPOSED BY: Senator Milton E. Potter, by Request of the Governor

WHEREAS, Consolidated Major Coastal Zone Management Permits Nos. CZJ-04-14 (W) and 1 2 6 CZJ-03-14 (L) were modified under Act No. 8407, enacted on December 31, 2020; and WHEREAS, development of the permitted project has been delayed by numerous legal 3 actions as well as modifying the project to meet the requirements of the United Staes Army 4 Corps of Engineers ("USACE") to receive approval of Permit Application #SAJ-2004-12518; 5 6 and WHEREAS, since ratification, the permittee has made substantial environmental and 7 regulatory progress, including securing a favorable section 106 determination and implementing 8 numerous environmental enhancements; and 9 WHEREAS, the USACE is expected to issue the corresponding federal permit in the 10 upcoming quarter; and 11 WHEREAS, the modification and extension must be approved to ensure the permit 12 remains in full force and to avoid jeopardizing federal approval and project financing; and 13 WHEREAS, the Summer's End Marina project is anticipated to bring over \$130 million 14 in private investment, hundreds of construction and permanent jobs and long-term growth to 15 16 the Virgin Islands, especially the island of St. John; and

- 1 WHEREAS, the project will also improve disaster preparedness and maritime resilience
- 2 in Coral Bay by providing critical emergency access and staging infrastructure in collaboration
- 3 with the Virgin Islands Territorial Emergency Management Agency and the Federal
- 4 Emergency Management Agency; Now, Therefore,
- 5 Be it enacted by the Legislature of the Virgin Islands:
- 6 SECTION 1. Pursuant to 12 V.I.C. § 911(g), the Legislature of the Virgin Islands ratifies
- 7 the Governor's approval of the Modification and Extension of Consolidated Major Coastal Zone
- 8 Management Permit Nos. CZJ-04-14 (W) and CZJ-03-14 (L), as documented in the Governor's
- 9 letter to Ms. Chaliese Summers, Managing Member of the Summer's End Group, LLC, dated
- 10 July 31, 2025, titled "Modification and Extension of Consolidated Major Coastal Zone
- Management Permit Nos. CZJ-04-14 (W) and CZJ-03-14 (L); the Summer's End Group, LLC",
- 12 for the construction of a marina and various supporting facilities in Coral Bay, St. John.

PROPOSED BY: Senator Milton E. Potter, by Request of the Governor

- WHEREAS, on July 15, 2025, the Virgin Islands Economic Development Authority
- 2 approved the Hotel Development Agreement between the Government of the Virgin Islands
- and Haven Development, LLC for the construction of a branded hotel located at Parcel No. 2
- 4 Estate Thomas, 6F New Quarter, St. Thomas consisting of 126 guestrooms, a pool, indoor and
- 5 outdoor bar patio, small kitchen facility for limited breakfast services, fitness center and
- 6 meeting room space; and
- WHEREAS, the Government of the Virgin Islands will make available for use 100
- 8 percent of the Designated Hotel Room Occupancy Tax and a 7.5 percent Economic Recovery
- 9 Fee, to pay and secure Hotel Development Notes for a period of 30 years or until such time as
- the direct investment of \$44,105,254.61 is reimbursed, whichever occurs earlier; and

- WHEREAS, pursuant to title 29 Virgin Islands Code, chapter 23, section 1307,
- 2 subsection (c), any project approved by the Virgin Islands Economic Development Authority
- 3 under the Hotel Development Program must be approved by the Governor of the Virgin Islands
- 4 and ratified by the Legislature of the Virgin Islands; and
- 5 WHEREAS, on August 13, 2025, the Governor of the Virgin Islands approved the Hotel
- 6 Development Agreement between the Government of the Virgin Islands and Haven
- 7 Development, LLC; Now, Therefore,
- 8 Be it enacted by the Legislature of the Virgin Islands:
- 9 **SECTION 1.** Pursuant to 29 V.I.C. § 1307(c), the Legislature of the Virgin Islands
- 10 ratifies the Hotel Development Agreement between the Government of the Virgin Islands and
- Haven Development, LLC for the construction of a branded hotel located at Parcel No. 2 Estate
- 12 Thomas, 6F New Quarter, St. Thomas consisting of: 126 guestrooms; a pool; indoor and
- 13 outdoor bar patio; small kitchen facility for limited breakfast services; fitness center and
- meeting room space, with the Government of the Virgin Islands making available for use 100
- percent of the Designated Hotel Room Occupancy Tax and a 7.5 percent Economic Recovery
- 16 Fee, to pay and secure Hotel Development Notes for a period of 30 years or until such time as
- the direct investment of \$44,105,254.61 is reimbursed, whichever occurs earlier.
