DEPARTMENT'S OVERVIEW

The Virgin Islands Fire and Emergency Medical Services (VIFEMS) was officially incorporated in 2022 to unify fire protection and emergency medical response across the territory. The agency currently operates 11 fire stations, including one sub-station on Water Island, and maintains two administrative offices territory-wide.

VIFEMS focuses on four primary areas of operation:

- **Suppression Unit**: Serves as the first responder tasked with the control and suppression of fire outbreaks as well as the containment of hazmat incidents.
- Arson Prevention Unit: Tasked with educating the public, investigating the origin of fires, business inspections, planning for the construction of new buildings for public use, and ensuring fire safety code compliance. With a goal of elevating territorial fire awareness, this unit is tasked with reducing the number of fire related incidents.
- Administration Unit: Provides effective management and financial support ensuring the success of the other units.
- Emergency Medical Services Unit: Manages ambulatory services territory-wide.

The mission of the Virgin Islands Fire & Emergency Medical Services is "To save lives, protect property and the environment while enhancing the quality of life through public education, fire prevention, code enforcement, and response to fires, medical emergencies, hazardous materials incidents, and all other man-made or natural disasters."

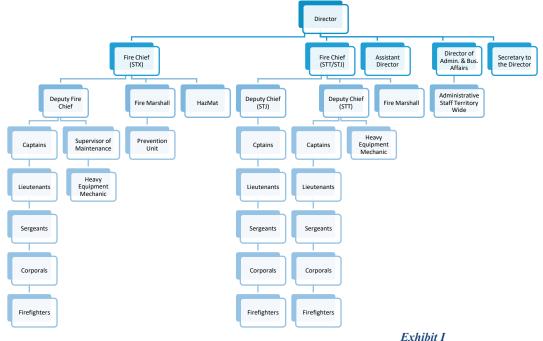
VIFEMS AT A GLANCE

During its Fiscal Year 2025 budget hearing before the Committee on Budget, Appropriations and Finance, the Virgin Islands Fire and Emergency Medical Services testified to the launch of several key initiatives aimed at strengthening operations and improving service delivery.

Based on the organizational chart submitted to the Post Audit Division, the Virgin Islands Fire and Emergency Medical Services formed through the consolidation of fire and EMS functions is led by a Director, supported by an Assistant Director and a Fire Chief in each district. This structure is intended to streamline leadership, enhance coordination across emergency services, and improve operational efficiency territory-wide. *Exhibit I* highlights the various positions within VIFEMS.



The Virgin Fire and Emergency Medical Services was appropriated *\$31,058,050* for Fiscal Year 2025 under Act No. 8916. Following the Office of Management and Budget's (OMB) revision of the FY 2025 budget, the agency's ceiling was reduced by **\$500,886** to accommodate the Single Payer Transfer.

VIFEMS has not received any additional appropriations outside of the FY 2025 Appropriation. A comparison between the actual appropriation in Act 8916 and the revised budget ceiling is shown below.

Virgin Fire and Emergency Medical Services received a revised budget ceiling of **\$30,557,164** from the General Fund for Fiscal Year 2025. As of June 17, 2025, the agency received **\$20,598,556** in allotments, representing **67.4%** of the total appropriation. Of the amount allotted, **\$30,302,682; or 98.6% was obligated**.

As of June 22, 2025, **expenditures totaled \$20,268,487**, **accounting for 99.8%** of obligations and **66.3%** of the total appropriation; indicating a high fund utilization for obligated amounts and demonstrate steady expenditure activity aligned with operational capacity. **It should be noted that Personnel Services accounts for approximately 67.8% of VITEMA's total General Fund appropriation, reflecting the agency's labor-intensive operational structure.**

FISCAL YEAR 2026 BUDGET SUMMARY

The Governor has recommended a **General Fund appropriation of \$36,488,123** for the Virgin Islands Fire and Emergency Medical Services for Fiscal Year 2026. **Exhibit III** provides a threeyear financial summary of the agency. However, the FY 2026 Executive Budget presents two different appropriation figures - \$36,188,123 and \$35,224,463 – reflecting a discrepancy of \$1,263,660. Additionally, a computation of the budget by activity centers yields a third amount of \$35,544,463, as illustrated in the chart below. This inconsistency warrants clarification to ensure accurate budgeting and legislative review.

According to the personnel information received from the Office of Management and Budget, funded positions accounts for **327 General Fund positions amounting to \$21,228,704**. **Resulting in a discrepancy of \$3,362,566**, for which no additional justification has been provided. The recommended budget includes **twenty-two vacant positions** funded under the general fund. The total funding allocated for these vacant positions amount to **\$1,106,633**.

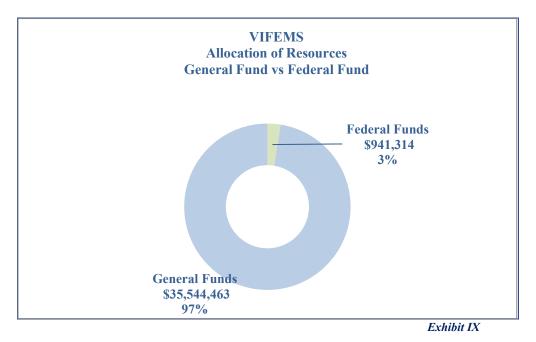

For Fiscal Year 2026, the Virgin Islands Fire and Emergency Medical Services is slated to receive **\$941,314 in support of federal programs**. When combined with the General Fund recommendation of \$35,544,463, the total recommended funding for FY 2026 amounts to **\$36,485,777.**

Grant funds will support key program areas within VIFEMS. Specifically:

- \$655,423 is allocated under Economic, Social, and Political Development of the Territories
- \$185,891 under Economic, Social, and Political Development
- \$100,000 under the State and Private Forestry Cooperative Fire Assistance program

Federal support accounts for approximately 2.6% of the total recommended funding while the General Fund makes up the remaining 97.4%.



OUTSTANDING VENDOR PAYMENTS

As of the current review, one outstanding vendor payment to Pafford Emergency Medical Services remains unpaid since FY 2024, totalling **\$3,399,288**.
