OFFICE OF THE TERRITORIAL PUBLIC DEFENDER'S OVERVIEW

The Office of the Territorial Public Defender (OTPD) is a semi-autonomous agency of the judicial branch of Government. OTPD was established under Title 5, Chapter 302, and Subsection 3520 on February 29, 1973, to represent indigent criminal defendants that appear before the Superior and Supreme Courts of the Virgin Islands. The OTPD is comprised of a district office on St. Thomas and one on St. Croix. Each division of the office is comprised of attorneys that are licensed to practiced law in the Virgin Islands or specially admitted to practice law in the Virgin Islands on behalf of the Office of the Public Defender.

The OTPD is governed by the Public Defender Administration Board which consists of:

- The President of the Virgin Islands Bar Association or his designee.
- Two appointees of the Presiding Judge of the Superior Court (one resident of St. Croix district and the other of St. Thomas/St. John district with one serving for three years and the other serving for two years.
- One appointee of the Governor the Virgin Islands who serves the same term as the person who appointed them.
- One appointee of the President of the VI Legislature who serves the same term as the person who appointed them.

The Public Defender Administration Board is authorized to:

- Hire or terminate all personnel and staff for the office, upon the recommendation of the Chief Public Defender, who is appointed for three years.
- Hear and decide on all complaints and grievances of employees.
- Promulgate rules and regulations governing employees' rights and regulations.
- Approve the annual budget for the office.

The Chief Public Defender's duties and responsibilities include:

- Make an annual report to all board members containing a brief summary of all cases handled by the office during the preceding year.
- Annually survey all federal prisons (which house prisoners incarcerated for the conviction of the violation of a criminal statute of the Virgin Islands) to determine if the facility has made Virgin Islands legal publications and material available to its prisoners.

The Public Defenders duties and responsibilities include:

- Counseling and defending their clients at every stage.
- Devote full-time to the discharge of their duties and cannot directly, or indirectly, engage in the private practice of law.

OFFICE OF THE TERRITOTIAL PUBLIC DEFENDER AT A GLANCE

As of June 30th, the Office of the Territorial Public Defender received \$4,087,983 in allotments, representing approximately 67% of its total FY 2025 appropriation.



As of June 12, 2025, the Office of the Territorial Public Defender reported the following financial activity based on its FY 2025 General Fund appropriation of \$6,132,220:

• Allotted Funds: \$4,087,983

- Represents 67% of the total appropriation

• **Obligations**: \$3,653,247

- Represents **59.5%** of the total appropriation

- 88.5% of the allotted funds have been obligated

• **Expenditures**: \$3,653,247

- Represents **59.5%** of the total appropriation

• Remaining Balance from Appropriation: \$2,784,973

- Represents 45.4% of the total appropriation

• **Unallotted Funds**: \$2,044,237

While OTPD obligated over 89% of allotted funds, 33.3% representing \$2M of the total appropriation remains unallotted.

FISCAL YEAR 2026 BUDGET SUMMARY

The Governor has recommended a General Fund appropriation of \$6,132,220 for the Office of the Territorial Public Defender for Fiscal Year 2026. However, OTPD has submitted a budget request of \$6,696,220, representing an increase of \$564,000 over the recommended amount.

PERSONNEL SERVICES

The Office of the Territorial Public Defender submitted a FY 2026 budget request of \$4,060,000 for personnel services. A personnel listing was provided itemizing salary costs for unclassified personnel totalling \$3,954,707.72. The difference of \$105,292.28 remains unaccounted for in the itemized personnel breakdown.

OTPD was awarded a sub-recipient award (Federal Award ID No. SLFRF318) in the amount of \$293,558.51 from the Government of the Virgin Islands through the Office of Management and Budget (OMB).

LOCAL GRANTS

The Office of the Territorial Public Defender will not receive any local grants for Fiscal Year 2026.

LEASES/RENTAL

Exhibit V presents a detailed listing of the properties owned and rented by the Office of the Territorial Public Defender. The Office currently generates \$33,900 per month in rental income. In addition, the St. Thomas office space is leased from Lindon Corporation at an annual cost of \$147,640.20.
