JUDICIARY OF THE VIRGIN ISLANDS' OVERVIEW

The Judiciary of the Virgin Islands is comprised of a Supreme Court and a Superior Court which also includes a Magistrate Division. The Supreme Court of the Virgin Islands is the highest local court and supreme judicial authority of the Virgin Islands. Pursuant to title 4, section 32(a) of the Virgin Islands Code, the Supreme Court of the Virgin Islands has appellate jurisdiction to review the final judgments rendered by the Superior Court, as well as a limited number of specified interlocutory orders. The Supreme Court also provides a second level of appellate review for appeals taken from the Magistrate Division of Superior Court. The Superior Court is the court of first impression in the Virgin Islands judiciary. As the trial court, it has broad jurisdiction in addressing the legal needs of the Virgin Islands community and has original jurisdiction to preside over all local civil, criminal, family, probate, landlord-tenant, small claims, and traffic disputes. It also acts as a court of appeals for decisions of all governmental officers and agencies. The Magistrate Division exercises jurisdiction over small claims, landlord/tenant issues, traffic, probate and petty criminal matters, and other powers as prescribed by law.

Pursuant to Act No. 7888 the local judiciary was administratively unified on July 29, 2016. Subsequent to the passage of this legislation on July 29, 2016, the Supreme Court amended VISCR 101 to establish the Judicial Branch Administrative Office (JBAO). Headed by an Administrator of Courts under the direction of the Chief Justice, the primary function of the Judicial Branch Administrative Office is the management and supervision of the day-to-day centralized non-judicial operations of the branch to include developing, implementing, coordinating, and enforcing all non-judicial matters throughout the branch related to policies, standards, procedures, programs, and personnel. JBAO, subject to the authority of the Chief Justice, is also responsible for the development of the budget and oversight of the expenditure of funds consistent with the judicial branch's budget, procurement, and disbursement policies.

The Office of Conflict Counsel (OCC) was established by court rule to handle indigent appointments in all cases in which the Office of the Territorial Public Defender has been disqualified or has been permitted to withdraw as counsel. The obligation to provide/fund indigent criminal defendants with court-appointed counsel in a manner that comports with *Gideon* (Right to Counsel under the 14th Amendment) ultimately belongs to the Legislature, and the unavailability of volunteer and involuntary appointed counsel, poses a significant threat of delay in criminal and family matters where constitutional and legislative mandates for appointed counsel exist. The Judicial Branch utilized American Rescue Plan Act funding to set up and begin to staff OCC and requested funding in the Fiscal Year 2026 Budget to fund the continued operations of Conflict Counsel which was legislatively enacted under Act No. 8960.

JUDICIAL BRANCH OF THE VIRGIN ISLANDS AT A GLANCE

The Judicial Branch received an allotment of \$41, 080,000 for Fiscal Year 2025. Of that amount, 83.3% has been allotted to date. Obligations that are committed but not yet expended amount to \$13,670,870. This figure equates to 33.3% of the full appropriation. The obligated amount which is adjusted for ARPA funding of \$1,088,366 will transition into expenses such as personnel, contractual services, capital outlay and utilities before the fiscal year ends.








During the

Allotments to date represent 75% of the Judicial Council's FY 2025 Appropriation, leaving \$32,655 or 25% unallotted. With 63 % of funds already expended and 40% obligated, the Council is in line with mid-cycle utilization. Given the appropriation did not fully cover personnel and fringe costs, the question remains, how did the Council source the funding gap?

As of July 2025, the Judicial Branch has received allotments totalling \$34,231,960, which is 83.3 % of the annual appropriation. Consequently, \$6,848,040 (16.7 %) of the full appropriation remains unallotted as of July 14, 2025.

Expenditures represent 69% of the Appropriated amount and approximately \$5,734,464 (13.9%)—is part of the pipeline associated with existing obligations that have not yet been disbursed.

Obligations to date stand at \$52, 250 and represents 40% of the appropriation. These obligations are exclusively for personnel services. Further,

- Total expenditures (actual payments) reached \$82,558, representing 63% of the appropriation.
- The remaining unexpended balance is \$48,062, equivalent to 36% of the total appropriation.

Of the \$48,062 remaining,

- \$32,655 (25%) has not yet been allotted and remains unavailable for future allotments.
- \$15, 407 (11%) is tied to obligations already incurred for personnel services but not yet disbursed as expenditures.

FISCAL YEAR 2026 BUDGET SUMMARY

The Judicial Branch of the Virgin Islands is slated to receive a lump sum of \$40,258,400 from the General Fund for Fiscal Year 2026. The Branch is requesting a sum of \$53,086,889 which is \$12,828,489 more than the Governor's recommendation. The Branch's Fiscal Year 2025 expenses thus far, prior year's expenditures, as well as their Fiscal Year 2026 budget request are listed in *Exhibit V*.

VEHICLES

The Judicial Branch has a total of one hundred and thirty-eight (138) vehicles. Of the one hundred and thirty-eight (138) vehicles, sixty-seven (67) are in the district of St. Thomas/St. John and seventy-one (71) are on St. Croix. All vehicles of the Court were purchased with local funds and insurance proceeds. A detailed vehicles listing can be viewed in *Appendix II*. As of May 31, 2025, the Court's vehicle expenditures list a total cost of \$144,475.78.

OUTSTANDING OBLIGATIONS

Appendix III depicts the Judicial Branch's Outstanding Obligations totaling \$365,426.50.

SUMMARY

The Judicial Branch of the Virgin Islands has submitted its Fiscal Year 2026 Operating Budget request in the amount of \$53,086,889. The projected sum is an increase of \$12,828,489 over the Governor's recommendation of \$40,258,400. The Branch is also requesting \$145,342 or \$14,722 more than the Governor's recommendation of \$130,620 for the Judicial Counsel. Act No. 8960 (Bill No. 35-0336) appropriated the sum of \$500,000 to the Judicial Branch of the Virgin Islands to establish the Office of Conflict Counsel. To date, the Judicial Branch has indicated that they have not received the funds. The projected Fiscal Year 2026 Office of Conflict Counsel is \$1,105,131.
