DEPARTMENT'S OVERVIEW

The Virgin Islands Waste Management Authority (VIWMA) was established to develop, implement, and manage an integrated solid waste and wastewater system for the U.S. Virgin Islands. As a semi-autonomous agency, VIWMA was created to address critical environmental and public health concerns by modernizing the territory's waste collection, treatment, and disposal infrastructure.

Today, VIWMA's mandate extends far beyond traditional waste management. In response to increasing environmental challenges, regulatory requirements, and community expectations, the Authority is tasked with ensuring compliance with federal and local environmental laws, promoting sustainability, and safeguarding the territory's natural resources. Its responsibilities now include the management of municipal solid waste, hazardous waste, wastewater treatment plants, pump stations, sewer collection systems, and landfill operations across all islands.

VIWMA also plays a key role in the Territory's climate resilience strategy, focusing on sustainable waste diversion practices, recycling initiatives, public education, and long-term infrastructure planning. This analysis reviews the Authority's operational performance, funding needs, and strategic direction in addressing the complex waste and wastewater challenges of the present day.

The Virgin Islands Waste Management has a Governing Board of Directors which comprises seven members. The seven members should include three (3) individuals from the public sector and (4) four individuals from the private sector. *The current active board members are listed below:*

VIWMA AT A GLANCE

Act No. 8899 Appropriated \$35,000,000 to the VIWMA. The Agency received additional funding in the amount of \$5,000,000 from the Southern Trust Company Settlement Fund (Act No.8985) for a funding level of \$40,000,000 from the Government of the Virgin Islands for FY 2025.

FISCAL YEAR 2026 BUDGET SUMMARY

The Governor has recommended a General Fund lump of the budget for FY 2026 in the amount of \$35,200,00. Other recommended amounts for FY 2026 totals \$7,000,000 (Tourism Advertising Revolving Fund-\$500,000, Antilitter Beautification Fund-\$5,000,000, Sewer Wastewater Fund-\$1,500,000). The amounts of \$32,500,000 and \$7,000,000 are used to build the FY 2026 budget for VIWMA. Exhibit II displays a financial summary of the General Fund and Other Funds for FY 2024-FY 2026.
