DEPARTMENT'S OVERVIEW

The Virgin Islands Casino Control Commission (VICCC)) was established by Title 32 Virgin Islands Code Chapter 21, as amended, in November 1995. The Commission is an independent agency of the Executive Branch of the VI Government, whose budget shall be approved annually by the VI Legislature. The Casino Control Commission consists of three (3) board members, appointed by the Governor with advice and consent of the Legislature. All members must be US Citizens and legal residents of the Virgin Islands, while two (2) of the members are to be residents of St. Croix district, and one (1) member from St Thomas/St. John district. No member of the Legislature, or person holding elected or appointed office in the Federal or Territorial government shall be eligible to serve as a member of the Commission.

Commission members serve terms of five years; however, no member shall serve more than two consecutive five-year terms. The Chairman shall be the Chief Executive Officer of the Commission, and all members shall devote full time to their duties of office and shall not pursue or engage in any other business, occupation, or other gainful employment. Members shall serve for the duration of their terms and until their successors are duly appointed and qualified; however, in the event that a successor is not duly appointed and qualified within 120 days after expiration of a member's term, a vacancy shall be deemed to exist.

The Commission is mandated by law to develop and implement a regulatory framework that permits and promotes the stability and continuity of casino gaming in the district of St. Croix, declared as the "Casino Zone" within the Territory. The Commission is legally required and authorized to:

- Issue and register licensees to applicable clients, employees, and service industries
- Collect fees associated with registration, impose levies, and penalties
- Conduct investigatory and other civil hearings pertinent to:
 - o Decisions on all licenses
 - o Registration
 - Certificates
 - o Matters affecting suspension, revocation, or renewal of applications
- Administer rules and regulations regarding the manufacture and sale of gaming devices
- Ensure compliance of Title 32 and related laws under the jurisdiction of the Commission
- Conduct daily inspections within the gaming industry to ensure:
 - Verification of the source of Casino(s) revenues
 - o Examine documentation and proper financial recording of revenues
 - o Review public complaints on conduct of gaming and waging operations
 - Conduct periodic reviews of Casino facilities
 - Make necessary adjustments to enhance the growth of the Tourism Industry

The Department of Justice, Division of Gaming Enforcement communicates with the Commission, and provides new and/or ongoing matters for investigation, prosecution, and evidence of a violation of the Virgin Islands Casino and Resort Laws.

The Commission is also mandated to carry on a continuous study of the operation and administration of casino control laws which may be in effect in other jurisdictions and the continuous updates to federal laws which may affect the operation of casino gaming and citizen's reactions thereto. The Commission is likewise responsible for ascertaining any defects in the Act, Rules or Regulations, and formulating recommendations for changes to the Governor and the Legislature.

VICCC AT A GLANCE

Act No. 8916 Appropriated \$1,423,800 to the VICCC. The Commission did not receive any additional funding for FY 2025.

During Fiscal Year 2025, the Virgin Islands Casino Control Commission announced its intent to enter into a Memorandum of Understanding (MOU) with the Virgin Islands Department of Health to facilitate the training and certification of gambling addiction counselors. This initiative aims to expand local capacity to address gambling-related mental health needs by leveraging the Alliance on Responsible Gaming Fund. Through this collaboration, the Commission seeks to provide accessible, community-based resources for patrons experiencing gambling addiction, aligning with its broader mandate to promote responsible gaming practices within the territory.

Results:

The Virgin Islands Casino Control Commission has successfully executed an MOU with the Virgin Islands Department of Health to fund the training and certification of six (6) counselors currently employed by DOH in the treatment of gambling addiction. The coursework has been fully funded and completed, and the counselors are now preparing to take the certification examinations.

Additionally, the Virgin Islands Casino Control Commission is moving forward with plans to develop and implement a territory-wide problem gambling and responsible gaming awareness campaign. This initiative will utilize a variety of outreach methods, including specialized web pages, social media platforms, electronic billboards, and mobile advertising, to effectively reach and educate the public.

As part of its broader commitment to organizational development, the Commission also intends to provide technical training and other educational opportunities for its staff. These efforts will support the implementation of key initiatives while reinforcing a positive and productive workplace environment within the Commission.


Results:

In March of 2025, the Commission launched Playwise.org, a website dedicated to responsible gaming and problem gaming territory wide. The website contains information related to problem gambling and responsible gaming and self-assessment tools. The information is available in English, Spanish and Haitian Creole. In addition, it provides links to national resources such as 1-800GAMBLER for calls, texts and live chats.

FUND FLOW ANALYSIS

For Fiscal Year 2025, the Casino Control Commission was appropriated \$1,423,800 for Personnel Services. As of May 31, 2025, the Commission has expended approximately \$1,241,338, which represents approximately 87.2% of the total appropriation.

This leaves a remaining balance of \$182,462, or 12.8% of the original allocation, available for personnel-related expenses for the remainder of the fiscal year. The Commission is on pace to fully utilize its Personnel Services appropriation by the end of the fiscal year, assuming consistent spending levels remain the same.



FISCAL YEAR 2026 BUDGET SUMMARY

For Fiscal Year 2026, the Governor has recommended a General Fund lump sum appropriation in the amount of \$1,723,800 to the Casino Control Commission. This appropriation is included under the Miscellaneous Section of the Executive Budget and is intended to support the Commission's staffing levels throughout the fiscal year.

EXPENDITURES

Exhibit II provides a detailed breakdown of expenditures reported by the Virgin Islands Casino Control Commission, including actual expenditures for Fiscal Year 2024, Year-to-Date expenditures for Fiscal Year 2025 (covering the period October 1, 2024 through May 31, 2025), and the projected expenditures for Fiscal Year 2026. This exhibit offers a comprehensive view of the Commission's spending trends and anticipated financial needs over the three-year period.

FEDERAL GRANTS
