#### VIRGIN ISLANDS ELECTION SYSTEM OVERVIEW

The Office of the Supervisor of Elections was established by Act No. 936 on February 20, 1963, which was later amended by Act No. 5157. The Election Reform Act of 1984, and codified in Title 18, Chapter 1, Section 4, of the Virgin Islands Code. The Supervisor of Elections is charged with the responsibility of administering and regulating the election laws of the Territory and is subject to the direction, control, and supervisor of the Boards of Election. This includes certifying to the Boards of Election the names of candidates for primaries and general elections; determining sufficiency of nomination petitions; receiving reports from the Deputy Supervisor and requiring such additional reports as deemed necessary; maintaining records of registered voters; hiring perdiem employees and performing administrative duties involved in maintaining offices in St. Thomas, St. John, and St. Croix; and preparing for the review and approval of the Joint Boards annual budget for the Boards. The Supervisor of Election has the direct responsibility for administering the provision of the Campaign Disclosure Law.

The primary objective of the Office of the Supervisor of Elections is to ensure the integrity of elections and uphold accurate voter registration records for citizens of the Virgin Islands, adhering to both federal and local laws, policies, and court rulings. This commitment encompasses a dedication to excellence and proficiency, fostering public trust in the fairness and impartiality of elections, while also facilitating equal participation in the democratic process for all individuals.

The Virgin Islands Board of Elections was created through Act No. 936 on February 20, 1963, by the Legislature of the Virgin Islands. The authority for the Election System of the Virgin Islands is derived from Title 18 of the Virgin Islands Code. The statute establishes the organizational structure of the Agency, which is comprised of four divisions: Joint Boards of Elections, St. Thomas-St. John District Board of Elections, St. Croix Board of Elections, and the Office of the Supervisor of Elections. Each District of Elections consists of seven (7) members elected from the respective districts for a four (4) year term: the St. Thomas-St. John District must include two (2) members who reside on the island of St. John. The Boards, within their respective districts, are the policy making bodies of the Elections System of the Virgin Islands.

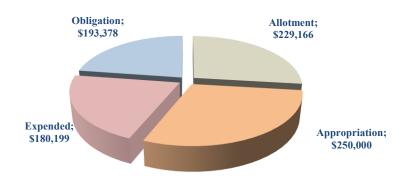

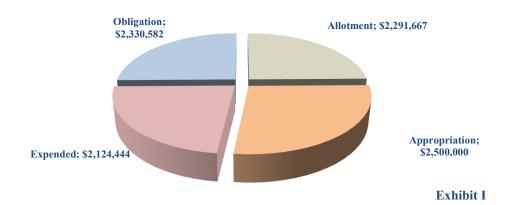
#### ELECTION SYSTEM OF THE VIRGIN ISLANDS AT A GLANCE

As of August 7, 2025, the Board of Elections received allotments totaling \$229,166, which represents 92% of its total appropriation of \$250,000. Similarly, the Supervisor of Elections received an allotment of \$2,291,166, also representing 92% of its total appropriation. These parallel percentages reflect consistent fund distribution practices across election-related entities. A detailed breakdown of these allotments is provided in *Exhibit I*.

#### **FUND FLOW ANALYSIS**

The System's Fiscal Year 2025 Fund Flow analysis outlines the Board of Election and Supervisor of Election budget across five key components: appropriation, allotment amount, obligations, expenditures, and balance available; and notes that the obligations reflect commitments made through September 30, 2025. As of FY 2025, the *Board of Elections* received a total appropriation of \$250,000 from the General Fund. The financial activity under this appropriation is summarized as follows:

- Allotments Issued: \$229,166 representing 92% of the total appropriation. An unallotted balance of \$20,834 (8%) remains, which has not been made available for obligation or expenditure.
- **Obligations** Incurred: \$193,378.32, representing **84%** of the total allotments and **77%** of the total **appropriation**. The unobligated allotment balance is therefore \$35,787.68.
  - o The Board stated that \$13,128.37 has been obligated for board members stipends and travel for the remaining months of the fiscal year.
- Expenditures: \$180,198.95 equates to 93% of obligations and 79% of total allotments. Compared to the total appropriation, 72% has been expended.
- Remaining Available Funds:
  - o Unobligated Allotted Funds: \$35,787.68
  - o Unallotted Funds: \$20,834.00
  - o Total Remaining Balance: \$69,801.05, which represents 28% of the total appropriation.

As of FY 2025, the *Supervisor of Elections* received a total appropriation of \$2,500,000 from the General Fund. The office's financial activity reflects a high rate of fund utilization and active obligation management. A summary is provided below:

- Allotments Issued: \$2,291,166.67 representing 92% of the total appropriation. An unallotted balance of \$208,333.33 (8%) remains to be made available.
- Obligations Incurred: \$2,330,582.20. This amount exceeds the total allotments by \$39,415.53, indicating over-obligation relative to current allotments. Obligations represent 102% of the total allotment and 93% of the total appropriation.
  - The Office reported that \$206,138.20 has been obligated to pay outstanding vendor payments.
- Expenditures: \$2,124,444.00 equates to 91% of obligations and 93% of allotments. Compared to the total appropriation, 85% has been expended.
- Remaining Available Funds:
  - o Unexpended Obligated Balance: \$206,138.20
  - o Unobligated Balance: Due to obligations exceeding allotments, this amount is negative relative to the allotment.
  - o Unallotted Funds: \$208,333.33
  - Total Remaining Balance: \$375,556.00, which represents 15% of the total appropriation.

#### FISCAL YEAR 2026 BUDGET SUMMARY

For Fiscal Year 2026, the Governor has recommended a General Fund Lump Sum appropriation of \$2,500,000 for the *Supervisor of Elections* and \$250,000 for the *Board of Elections*. These recommended appropriations are consistent with FY 2025 levels. A three-year financial summary for both the Board of Elections and the Supervisor of Elections is presented in *Exhibit IV*.

#### **PERSONNEL SERVICES**

The Office of Management and Budget (OMB) submitted a personnel listing for Fiscal Year 2026 reflecting thirteen (13) budgeted positions with a total salary cost of \$947,429.73 and fringe benefits totalling \$385,211.50, resulting in a combined personnel cost of \$1,332,641.23. In contrast, the Election System of the Virgin Islands has projected a total personnel expenditure of \$1,241,357.05 for the same period.

This results in a variance of \$91,284.18 between OMB's submission and the Election System's projection. The difference is attributed to two components:

- A \$2,820.73 reduction associated with an election assistant position, and
- A \$88,463.45 decrease in fringe benefits.

#### **OUTSTANDING VENDORS**

\*\*\* According to Post Audit's calculations, discrepancies have been identified in the reported annual rent amounts for two lease agreements. For Market Place, LLC, the annual rent—highlighted in yellow in the submitted documentation—should be \$21,230.30, rather than the reported \$38,128.43, resulting in a discrepancy of \$16,898.13. Conversely, the annual rent for Lockhart Management, Inc. should total \$123,729.06, compared to the reported \$105,165.22, reflecting a shortfall of \$18,564.06.

#### **FEDERAL GRANTS**

The Governor's Fiscal Year 2026 Budget does not indicate that the Election System of the Virgin Islands is scheduled to receive any federal funding. The Office of the VI Election System indicated the following as federal funding for Fiscal Year 2026 show as *Exhibit VIII*.

During the Fiscal Year 2025 budget process, ESVI indicated that they received Federal Funds in the amount of \$1,600,000 from Help American Vote Act (HAVA) for Security. HAVA established a program to provide federal funds to states and territories to upgrade voting systems and improve the administration of federal elections. The formula grants go directly to states and U.S. territories to support the administration of elections for federal office and improvements to voting and election systems. States and territories do not compete for the funds which are distributed based on predetermined formulas and eligibility requirements.

#### **VEHICLES**

The Virgin Islands Election System has five (5) vehicles in its fleet. Three (3) vehicles in the district of St. Thomas/St. John, and two (2) in the district of St. Croix. *Exhibit IX* depicts a detailed listing of vehicles for Fiscal Year 2026.
