LEGAL SERVICES OF THE VIRGIN ISLANDS, INC. PRESENTATION TO THE 36th LEGISLATURE OF THE U.S. VIRGIN ISLANDS August 15, 2025

2024 STATISTICS

During the full year 2024, with a new federal administration and the COVID-19 pandemic in the rearview mirror, Legal Services of the Virgin Islands, Inc. (LSVI) has continued to conduct in-home and hospital visits for housebound senior citizens or other infirmed persons that need on-site legal assistance. Client intakes occur daily by telephone, on-line, in-person, and at the Mobile Justice Units. LSVI has increased community education and outreach to the territory's most vulnerable citizens through its Senior Medicare Patrol (SMP) along with the Project Directors for Elder Law, Violence Against Women Act (VAWA) and Victims of Crime Act (VOCA). Additionally, LSVI has made substantial progress to increase the number of community stakeholders and partners with whom we have participated in collaborative activities.


A comparison of LSVI's case numbers for 2024 with the case numbers for 2023 reveals a marginal increase of client cases opened year to year from 1,393 in 2023 to 1,412 in 2024. In 2024, the cases opened increased by < 2% over 2023. During the 2024 calendar year, the St. Croix office had 952 cases while the St. Thomas office had 460 cases for a total of 1,412 cases for the 2024 year. This is likely due, in part, to the consistency of the intake processes.

Overall, the organization witnessed a marginal increase in case numbers in 2024 as compared to the same time periods in 2023 even with a fewer number of attorney resources in 2024. Moreover, in Q1 and Q2 2025, LSVI has observed roughly an 18% increase in cases as compared to the same time period for Q1 and Q2 2024. The majority of LSVI's clients continue to be senior citizens (60+) followed by the 26–45-year-old adult client cohort.


During the 2024-year, family law matters surpassed estate planning and are now the predominant case type. LSVI has observed marked increases in housing (+17%) and family (+18%) cases so far in 2025 over the same period in 2024.

LSVI continues to maximize the organization's resources to provide advice and counsel and/or brief services to the vast majority of the clients. However, LSVI will indeed engage in full representation when and where necessary to ensure that the rights of our clients are protected. LSVI strives to ensure that each client receives equal access to justice, anytime, anywhere!


The following chart provides a breakdown of LSVI's 2024 cases by the legal issue clients faced:

Client Stories

A. Domestic Abuse.

A domestic violence (DV) incident occurred involving the client and the abuser. The pair share two children. The DV, which included both verbal and physical abuse, was a recurring pattern that was ongoing for three (3) years prior to the incident. The police were called when the abuser had assaulted the client in the past. The client and the abuser had formally broken up and separated, and since the separation the abuser had become very difficult, verbally abusive and refused to assist with their children and/or the children's care bills, etc. The pair had been coparenting their children using an alternating schedule since Fall 2024. Prior to that, and since their separation the client had been parenting their children on the client's own. On the incident date, the abuser battered their child over the child's refusal to cooperate during a bath, which left visible bruising and darkened marks on the child's thighs and extremities. The beating was corroborated by photographs of the child's visible injuries and the abuser's text message(s) to the client. A further domestic violence incident with the same parties occurred after the client retreated to the abuser's grandmother's house because of gun shots in the client's housing community. The abuser became aggressive and upset about the client desiring to

return to her own home with their children after the commotion from the shooting had subsided. The abuser stormed the home and banged on the door, making threats of violence and terror that were overheard by the neighboring unit. The neighbor feared for the client's safety and called the police and made a recording of his threats to "shoot the place up". The client visited the police station after the cops did not arrive timely and informed VIPD about the DV and the child abuse. The abuser was arrested. The client subsequently lodged a DV claim and LSVI assumed the representation. The matter proceeded to trial and a DV trial was had before the Honorable Yolan Brow Ross. The abuser was represented by counsel. The client prevailed at trial and the Superior Court awarded her a six (6) month permanent restraining order (PRO) finding that DV had occurred despite her testifying that she did not sustain any physical injury. LSVI has been able to obtain numerous permanent restraining orders for domestic violence survivors. In instances where there is physical violence the organization customarily obtain Pros for the maximum two-year period. The organization will continue to intercede on their behalf when clients seek a PRO on the merits and the facts and evidence support their claim(s).

B. Employment Matters.

An LSVI client was terminated from employment with a local 501(c)(3). The client filed for unemployment insurance *pro se* and the claim was denied by the Department of Labor (DOL). LSVI intervened on behalf of the employee and lodged an appeal with the DOL. The employer retained counsel on the eve of trial and thereafter the progression of the matter stalled with motion practice, new discovery deadlines and a remote date for a trial. The employer alleged that the client had been terminated for misconduct and absenteeism pursuant to its employment manual. The employee alleged wrongful termination and a pattern of discrimination. With the lines drawn, the client was advised of employee rights and remedies and LSVI began preparation for a trial. During the course of discovery, LSVI was able to negotiate a settlement of all claims, which resulted in the client receiving two lump sum installments in lieu of dropping the unemployment and wrongful termination claims. In discovery, LSVI had determined that the employer as a "reimbursing employer" would have had to reimburse the Department of Labor for the employee's unemployment insurance award. LSVI leveraged this finding to calculate various

payout scenarios and negotiate a favorable settlement for the client. The calculations revealed that the employer would have paid out more from a successful unemployment appeal (i.e., the award and attorneys' fees, etc.) than if it settled the case. And the client agreed to the settlement because it allowed the client to receive a lump sum pay-out. The client desperately needed the lump-sum to cauterize cascading debt and expenses and to support the client's family.

C. Eviction Prevention and Housing Stability.

LSVI is committed to preserving tenants' rights and promoting housing stability in the Territory. LSVI recently represented several tenants in forcible entry, detainer, and restitution ("FED") actions in the Virgin Islands Superior Court's Magistrate Division. In one such FED action, LSVI obtained an early dismissal by lodging a pre-answer motion to dismiss in advance of the initial court appearance on the grounds that the client had vacated which rendered the action moot. LSVI had coordinated with local housing providers to identify and secure replacement housing for the client in advance of the court hearing. This avoided the need for an appearance altogether and helped support judicial economy.

In two additional FED actions, LSVI assumed full representation and appeared in the Superior Court on behalf of clients in nonpayment FED actions. In the first action, LSVI was able to reach a favorable settlement of the matter that allowed the client and the client's family to remain in possession of the unit for an additional forty-five (45) days after the third hearing in the matter. Additionally, as part of the settlement, the client received \$3,000.00 or roughly four (4) months' rent to assist the client with moving costs and relocation expenses, etc. In the second action, LSVI also reached a settlement whereby the client remained in possession of the unit and through negotiation entered into a stipulated installment plan to satisfy rent arrears in exchange for a promise from the landlord to complete repairs and discontinue the action when the tenant satisfied the arrears.

LSVI has also assisted tenant's in obtaining repairs in numerous L&T matters by drafting notices and demand letters as well as acting as an escrow agent for tenants who desire to withhold their rent to gain leverage against landlords who

neglect to perform repairs and/or permit units to become uninhabitable. By withholding rent, a landlord has incentive to make repairs and service the unit. Often landlords insist that they do not have the money for repairs. This practice justifiably places the emphasis on the application of the tenants' rents or a portion thereof toward repair and rehabilitation costs.

The organization shall continue to provide high quality civil legal assistance to the low income and underserved community in the Territory and expresses our sincere gratitude to the Legislature of the Virgin Islands for its commitment to service and the advancement of the organization.

Community Outreach and Training
