An act appropriating \$4,892,000 from the GVI/JPMC Charitable Fund to the General Fund of the Treasury of the Government of the Virgin Islands

---

**PROPOSED BY:** Senator Novelle E. Francis, Jr.

*Be it enacted by the Legislature of the Virgin Islands:*

**SECTION 1.** The sum of \$4,892,000 is appropriated in the fiscal year ending September 30, 2026, from the GVI/JPMC Charitable Fund established by Act No.8922, section 2, to the General Fund of the Treasury of the Government of the Virgin Islands, to be distributed to the following organizations and programs funded by the Government of Virgin Islands through the miscellaneous section of the fiscal year 2026 General Fund budget:
