1 WHEREAS, on June 10, 2025, the Governor of the Virgin Islands approved the lease 2 agreement between the Government of the Virgin Islands and Commercial Investments LLC; 3 WHEREAS, Commercial Investments LLC is leasing Parcel No. 30 Submarine Base, 4 No. 6 Southside Quarter, St. Thomas, consisting of a one-story building situated on 5 approximately 17,396 U.S. sq. ft. or 0.399 U.S. acres of improved land, as shown on P.W.D 6 File No. D9-1425- T78, dated August 24, 1979, to be used for a logistics storage warehouse 7 and other related purposes; 8 WHEREAS, the premises is leased for an initial term of 30 years, with two options to 9 renew for two additional terms of 10 years each; 10 WHEREAS, the rent will be \$500.00 per month, for months one through twenty-four of 11 the lease, and \$48,000 per annum, payable in equal monthly installments of \$4000 thereafter;

1	WHEREAS, title 31 Virgin Islands Code, chapter 21, section 205, subsection (c)
2	provides that in addition to the Governor's approval of any lease, the Legislature of the Virgin
3	Islands must approve all leases exceeding a term of one year; Now, Therefore,
4	Be it enacted by the Legislature of the Virgin Islands:
5	SECTION 1. Pursuant to title 31 Virgin Islands Code, section 205, subsection (c), the
6	Legislature of the Virgin Islands approves the lease agreement between the Government of the
7	Virgin Islands, acting through its Commissioner of the Virgin Islands Department of Property
8	and Procurement and Commercial Investments LLC, for Parcel No. 30 Submarine Base, No. 6
9	Southside Quarter, St. Thomas, consisting of a one-story building situated on approximately
10	17,396 U.S. sq. ft. or 0.399 U.S. acres of improved land, as shown on P.W.D File No. D9-
11	1425- T78, dated August 24, 1979, for a term of 30 years with two options to renew for two
12	additional terms of 10 years each with an annual rent of \$48,000 to be used for a logistics
13	storage warehouse and other related purposes.
