ARTICLES OF INCORPORATION

OF

CHURCH OF GOD SEVENTH DAY, INC.

WE, THE UNDERSIGNED, all being of full age, for the

purpose of forming a non-profit membership corporation pursuant

to the provisions of Title XIII of the Virgin Islands Code, do

hereby make, sign, acknowledge and file the following as the

Articles of Incorporation:

I.

The name of the corporation is CHURCH OF GOD SEVENTH

DAY, INC.

II.

The purposes for which the corporation is formed are:

(1) To conduct services and to teach the Bible and to

follow the Commandments of God and the teachings of Jesus Christ.

(2) To conduct Bible classes and offer other religious

instructions.

(3) To administer Baptism to new members and converts.

(4) To develop and maintain programs of Christian

Social Welfare as needs are demonstrated and resources permit.

(5) To accept gifts of personal property and devise

of real property; to purchase, hold, lease, sell and/or convey

any property, real or personal.

(6) To borrow money, issue notes, bills or other

evidence of indebtedness.

(7) To mortgage or otherwise encumber any property

owned by the Church.

(8) To have all the powers of a non-profit organization

as particularly set forth in Title XIII of the Virgin Islands

Code.

(9) To do any and all acts necessary to the realization

of the above mentioned purposes, and to further pursue the faith

in Jesus Christ.

III.

The principal office of the corporation will be at 156 Estate Grove Place, St. Croix, U.S. Virgin Islands, and the resident agent will be Pastor Joseph Eudorlique.

IV.

The existence of the corporation will be perpetual and the corporation will commence business upon the filing of these Articles of Incorporation.

V.

The membership of the corporation shall consist of the confirmed members on the active role of the Church, who were baptized and duly admitted by the Board of Directors into the Church.

VI.

There shall be no limit to the indebtedness or liability of the corporation.

VII.

The corporation shall be managed by a Board of Trustees selected by the congregation at the end of each year. The Board of Trustees shall have full authority to govern the affairs of the corporation.

VIII.

The initial Board of Trustees shall consist of the following seven (7) individuals, each of whom shall serve until the first meeting of the members of the corporation:
