#### ARTICLES OF INCORPORATION

#### ANIMAL CARE CENTER OF ST. JOHN, INC.

We, the undersigned, all of lawful age, hereby unite together to form a nonprofit corporation pursuant to the provisions of Chapter 3 of Title 13 Virgin Islands Code as follows:

ARTICLE I. That the name of the corporation is Animal Care Center of St. John, Inc.

ARTICLE II. The corporation is formed for the following purposes:

- (1) To foster positive public relations between the community and the Animal Care Center and to promote education, involvement, and concern for the welfare of both feral and domestic animals on St. John.
- (2) To raise and recieve funds for both the care and control of animals on St. John.
- (3) To take and hold title to such facilities as may be dedicated, donated and conveyed to said corporation, and accepted by the corporation, or purchased by it, or in land acquired thereto, and to repair, maintain and control the use of the same.
- (4) To borrow money, with or without pledge or mortgage upon all or any of its property, real or personal, as security and to purchase and own or rent or lease such machinery, equipment and tools as may be necessary to its needs.
- (5) To buy, lease or otherwise acquire property and to sell, improve, assign, transfer, convey, lease, sublease, pledge or otherwise alienate or dispose of, and to mortgage or otherwise encumber the lands, building, real property, chattels, real and other property of the corporation, real and personal and wherescever situate, and any and all legal and equitable right therein.
- connection with the foregoing, and to have and exercise all of the powers conferred by Title 13. Chapter 3 of the Virgin Islands Code, and to do any and all of the things hereinbefore set forth, to the same extent as natural persons might or could do, and in any part of the world.

ARTICLE III. Initially the principal place of business shall be located at Connections, Parcel 6D, Cruz Bay Quarter, St. John, U.S.V.I. 00830. The name of its resident agent is Tonya Martin, and her physical address is 1023 Estate Carolina, Coral Bay, St. John, U.S.V.I. 00830.

ARTICLE IV. The corporation shall commence doing business immediately. The period of continuance of the corporation shall be perpetual.

ARTICLE V. The terms of admission of membership of this corporation are as follows:

- (1) A "member" as referred to herein means a member of the corporation.
- (2) Membership shall be determined on the basis of work performed, services rendered or contributions made to the corporation. No shares of stock shall exist or be issued by the corporation.
- (3) No person who shall cease to be a member shall have any right to or interest in any property of the corporation or any right of refund for any payment(s) or contributions previously made to the corporation.
- (4) The bylaws of the corporation shall further define the qualifications for membership as well as membership guidelines, etc.

ARTICLE VI. Initially, the highest amount of indebtedness to which the corporation shall be subject is \$25,000, which amount shall exclude any mortgage indebtedness.

ARTICLE VII. The affairs of the corporation shall be managed by a board of directors of not less than three members and not more than nine. Prior to the first annual meeting of the membership, the incorporators shall elect the initial board of directors which board shall, in turn, elect the initial officers to consist of a president, vice president, secretary, treasurer, and such additional officers.

## ARTICLE VIII. MISCELLANEOUS PROVISIONS

- (1) These articles of incorporation may be amended when authorized by a vote of two-thirds of the membership as set forth in 13, Virgin Islands Code, section 492.
- (2) Bylaws of the corporation shall be proposed and adopted as set forth in 13, Virgin Islands Code, section 495.
- (3) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (c) (3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code (or corresponding section of any future Federal tax code):

- (4) Upon dissolution of the corporation, all its assets shall be distributed for one or more exempt purposed within the meaning of Section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or shall be distributed to the Federal government, or to a state or local government, for a public purpose;


