BACKGROUND AND HISTORY

The Virgin Islands Taxicab Commission was re-established in 2007 by Act No. 6968 as a semi-autonomous agency.

The Commission is comprised of a seven (7) member board, appointed by the Governor with the advice and consent of the Legislature of the Virgin Islands. The names are as follows:

The Taxi License Fund is the sole funding source for this agency. This fund covers all personnel and operating expenses throughout the territory. Revenues for the Commission are derived from the issuance of business licenses, forms, publications, penalties, and citations.

The Virgin Islands Taxicab Commission is charged with the responsibility of regulating the:

- Automobile-for-hire industry which includes taxis.
- Tour operators and limousines.

In order to execute these responsibilities safely, the agency must improve operational efficiency and effectiveness by educating industry operators and consumers.

Achievements of organizational goals necessitate:

- a) Updating the Rules and Regulations Handbook for all automobile-for-hire operators and operators.
- b) Implementation of "United in Pride and Hope"; a professional development program de signed for the benefit of all first-time industry operators and all other industry operators interested in service improvement.

The automobile-for-hire industry is a valuable and critical asset to the Territory's #1 industry, tourism, and to the local community. Periodic reviews of policy and procedures ensure a safe, reliable, and regulated industry, as well as growth in revenue.

STRATEGIC AND PERFORMANCE GOALS

Strategic Goal(s):

- 1. Regulate the automobile for hire industry.
- 2. Maintain operational effectiveness and efficiency.

Performance Goal(s):

- 1. Ensure all businesses and individuals are licensed and in compliance.
- 2. Ensure all monies collected are deposited into the Taxi Licensed Fund.
- 3. Launch the Professional Development Program for all new industry operators.

BUDGET OVERVIEW


The Governor has recommended a Taxi License Fund appropriation of \$1,017,776 for FY 2024. This represents a decrease of (\$9,638) below the FY 2023 appropriation of \$1,027,414 (According to the FY 2024 Executive Budget Book). Exhibit I displays a budget overview (FY 2022-FY 2024).

POST AUDIT COMMENTS

The Governor's recommendation from the Taxi License Fund for FY 2024 is \$1,017,776. This represents a decrease of (\$9,638) below the FY 2023 appropriation of \$1,027,414. However, Act No. 8635 appropriated in Fiscal Year 2023 an additional \$305,312 in the Miscellaneous Section of the main budget act. This amount was not extended in FY 2024.
