SUBJECT: Bill No. 35-0190 – An Act to appropriate \$350,000 from the St. Croix Capital Improvement Fund to provide bottled drinking water to persons residing in the areas identified by the Virgin Islands Water and Power Authority as most impacted by elevated levels of copper and lead in the potable water system.

Section 1 of this bill seeks to appropriate \$350,000 from the St. Croix Capital Improvement Fund to provide bottled drinking water.

According to Fund Balances received by the Department of Finance, the St. Croix Capital Improvement Fund has an available balance of \$3,366,644.74 but according to **Exhibit I** the fund balance should reflect \$1,475,113. It is important to note that though there are monies available in the St. Croix Capital Improvement Fund to cover this expense, the distribution of bottled water is not a capital project. Based on the definition of the fund, monies are to be used exclusively for capital improvement projects on the island of St. Croix.

The Post Audit Division recommends that another funding source be used for this bill and does not recommend the approval of this bill.
