The Committee Hearing was called to order by Chairman Angel L. Bolques, Jr. at 10:08 am and convened to receive testimony on the following:

The Committee on Culture, Youth, Aging, Sports & Parks has scheduled a hearing for Friday, April 21, 2023, beginning at 10:00 am in the Earle B. Ottley Legislative Hall on the island of St. Thomas to receive testimony and updates regarding the progress and challenges of the Department of Sports, Parks & Recreation concerning their projects and their mission to provide high-quality, accessible programs, services, and facilities that enhance the quality of life for all ages, cultures, and abilities, as well as an overview and updates from the Department of Tourism regarding the upcoming cultural celebration of the 2023 St. Thomas Carnival.

Updates and overview of the Department of Sports, Parks & Recreation pertinent to their progress and challenges concerning their projects and providing high-quality, accessible programs, services, and facilities that enhance the quality of life for all ages, cultures, and abilities, (Strengths, Weaknesses, Opportunities & Threats). Additionally, provide an update on the department's role during the cultural celebration of the 2023 St. Thomas Carnival.

Invited Testifier:

The Honorable Calvert White Commissioner, Department of Sports, Parks & Recreation

The committee received a comprehensive testimony from Commissioner White that outlined recovery and capital projects, programs and partnerships, as well as a SWOT analysis breakdown. Senators did ask about some of the projects and the Commissioner assured that timelines will be met, and obstacles are being resolved expeditiously. He commended his staff on their ability to support all sports and all activities though there is a clear shortage of facilities and spaces. Senators wanted to encourage the department to increase their marketing and dissemination of information. Department noted that they hired a PIO to assist in this endeavor. Commissioner and his team gave the senate an update on the summer camps, to include number of camps and participants on each island. One of the main topics of conversation was around lifeguards, rapid response and emergency marine vehicles, lack of qualified person (STT specifically), etc. The commissioner is working with cruise lines and exploring other options to bridge the gap. The department also plans to improve their data collection process on facility usage. Staffing continues to be an issue across the department.

An overview and updates of AARP Virgin Islands, as well as challenges and progress concerning programs under AARP such as, but not limited to Health and Wellness, Family Caregiving, Seniors Work and Jobs, Community Engagement, and an overall update of the AARP foundation.

Invited Testifiers:

Troy Schuster State Director, AARP USVI

Senator Bolques spoke to the importance of providing the necessary tools, facilities, programs and initiatives for our aging population which makes up 20% of the USVI population, as stated by Mr. Schuster of AARP. He also mentioned that by 2030, the number of seniors will exceed the number of children in the United States. AARP was a primary advocate for the passage of the Commission on Aging within the Governor's Office. The Director's testimony outlined efforts and advocacy in financial security, affordable access to long-term care, as well as protections and safeguards from fraud and abuse. He also wanted to emphasize that AARP is not an insurance company, but social mission organization with a primary responsibility to advocate for the demographic they serve. Director Shuster talked about the partnership with Play by Design to create outdoor fitness parks and playgrounds. He also mentioned that a person can join at the age of 18. AARP is also feeling the effects of "The Great Resignation", where finding people to work post pandemic has been extremely difficult.
