The Committee Hearing was called to order by Chairman Angel L. Bolques, Jr. at [Time] and convened to receive testimony on the following:

The Committee on Culture, Youth, Aging, Sports, and Parks has scheduled a hearing for <u>Friday</u>, <u>August 25, 2023, 10:00 AM</u> at the <u>Fritz E. Lawaetz Legislative Chambers on St. Croix</u> to receive testimony and updates regarding the status of horse racing in the territory. Bills 35-0073 & 35-0083 will also be presented to the Committee for consideration.

BLOCK I: 10:00 AM – 12:00 PM

The committee will be receiving updates on the status of horse racing in the territory. This update will include, but not be limited to facilities construction, funding allocations, projected timelines, achievements, challenges, potential opportunities, and prevailing needs.

Southland Gaming (SGVI) and VIGL gave updates on the facilities under construction in both districts. Concerns were raised by Senators over the lack of movement with VIGL. Horsemen

spoke candidly regarding the lack of communication with VIGL and voiced concerns over the cost of maintaining a horse while not being able to recoup investment for lack of races. Commissioner White of DSPR raised apprehension to release funds while no movement on the track in St. Croix was happening. Reiterated the fact that VIGL has resources to continue development, which was corroborated by VIGL, and holding the government appropriation would not delay construction.

Honorable Senator Samuel Carrion presented two measures for consideration. During his presentation, he mentioned that this would not create two horseracing commissions, but rather would give each district the autonomy to address issues unique to them. Both "divisions" would them come together to form a territory horseracing commission that would set rules, regulations, and standards for both districts to adhere to. Horsemen were in favor of this measure, and the current commission supported the decision and position of the horsemen. Senators agreed that it would help expedite the resurgence of horseracing in the territory.
