The Committee Hearing was called to order by Chairman Angel L. Bolques, Jr. at 10:20am and convened to receive testimony on the following:

The Committee on Culture, Youth, Aging, Sports, and Parks has scheduled a hearing for <u>Friday</u>, <u>June 23, 2023, 10:00 AM</u> at the <u>Cleone H. Creque Legislative Annex on St. John</u> to receive testimony and updates regarding youth programs and initiatives from Department of Human Services, Department of Labor, as well as being introduced to key stakeholders who are promoting and facilitating aviation careers to our youth. The committee will also consider *Bill No. 35-0078* – a bill to require the Commissioner of the Department of Tourism to conduct a territory wide survey of the residents of the Virgin Islands to assist in the establishment of an official dish and dessert of the Virgin Islands</u>.

The Committee also received favorable testimony during the consideration of Bill No. 35-0078 a bill to require the Commissioner of the Department of Tourism to conduct a territory-wide survey of the residents of the Virgin Islands to assist in the establishment of an official dish and

dessert of the Virgin Islands. Assistant Commissioner Alani Henneman on behalf of Commissioner Boschulte assured the committee that the Department of Tourism was up to the task of developing and administering a survey to begin gathering information on the myriad of cuisines native to the Territory. They also assured the Committee that culture bearers will be included in the discussion. Supporters of this measure were Ambassadorial Chefs, Sandra Gerard-Leung and Julius Jackson. Though the members felt it difficult to come to a singular conclusion on a national dish and dessert, as well as the need to codify conducting a survey, they agreed that the concept further establishes the Virgin Islands' cultural and ethnic identity and enhances the USVI tourism product. The measure passed and will be forwarded to the Committee on Rules and Judiciary for further consideration.

The Committee on Culture, Youth, Aging, Sports & Parks convened in the Cleone H. Creque Legislative Annex today to highlight St. John based organizations, Love City Flight Club and Society 340, which are working on promoting aviation opportunities to our youth. St. John resident, pilot, and instructor, Justin Bartosh, who rounds out the triumvirate of aviation advocates, and continues to support the work of Ms. Dawson and Ms. Parsons through a multifaceted partnership. Dr. Suzanne Darrow-Magras, Director of UVI CELL, along with Program Specialist and Coral Wings Project Coordinator, Mrs. Janet Gonzalez-Rosario, spoke about the Coral Wings program, made possible by a recently awarded FAA grant, and encouraged young people to apply to the program.

(LIFT) Internship Program, the Career Exploration Program, Jobs for America Graduates (JAG), and the Senior Community Services Employment Program (SCSEP) and any other services or programs that the department offers for the youth and aging (elderly) population.

Commissioner Kimberly Causey-Gomez and her team gave updates on Youth and Aging Services & Programs such as Intervention & Prevention Services, Head Start Programs, Youth Rehabilitation Center, Foster Care, Homes for the Aged, and Senior Recreation Centers. She highlighted the federal funding earmarked for the reconstruction of Head Start playgrounds throughout the Territory, the installation of security cameras and surveillance systems at all Head Start sites, as well as support for six major Head Start construction projects spanning all three islands. Commissioner Causey-Gomez also elaborated on the status of current programs within the agency to support the Territory's aging population. Funding for these programs remains one of the major inhibiting factors for expansion and comprehensiveness. Department of Labor Commissioner, Gary Molloy (and team) gave testimony and answered questions regarding the department's career path opportunities and services, specifically the Summer Youth Work Experience, (SYWEP), Labor Investing for Tomorrow (LIFT) Internship Program, the Career Exploration Program, and Jobs for America Graduates (JAG-VI). He highlighted the great work of the Youth Team, which is responsible for in-house academic and career assessments to determine the services and activities for youth, which services over 800 young people annually. One of the other points of interest was the Registered Apprenticeship Program, which is intended for long-term employment. Participants in this program earn a wage while also getting on-the-job training and job-relevant education
