INTRODUCTION

Good day, Honorable Senators – Chairperson, Senator Javan James, members of the Committee on Economic Development and Agriculture, and other senators present. We are here to present testimony in response to your letter of February 16, 2023, regarding updates about the Virgin Islands Department of Agriculture's (VIDA) operations. I am Diana Collingwood, Assistant Commissioner of VIDA. I bring you warm regards on behalf of Commissioner Louis E. Petersen, Jr. who could not be present today due to a schedule conflict. Here with me today are Deputy Commissioner Riise Richards, Director of Administration and Management Aaron Bryan, and Director of Agricultural Development James Henderson. Available virtually are Marketing Program Acting Director Shantel Douglas, NACD Technical Assistance Coordinator Gracia Lettsome, Forest Stewardship Coordinator Mathilde Wilson, and Urban and Community Coordinator Preston Brooks. Although not physically present, we would like to acknowledge and express our sincere appreciation to the rest of the hardworking men and women of the Virgin Islands Department of Agriculture, and all farmers throughout the territory.

The mission of our agency is to develop, support, and promote an economically lucrative agricultural industry in the U.S. Virgin Islands while supporting farmers, consumers, and the environment. According to the Virgin Islands Code, our primary responsibilities include providing basic agricultural services and technical support; creating activities and opportunities for the marketing and production of farm produce; inspecting and regulating agricultural products; investigating and regulating insect, animal, and plant diseases and environmental protection laws; supervising coordination, cooperation, and compliance in federally aided or sponsored agricultural

programs; and advocating or disseminating policies, rules, and regulations that allow for the effective exercise of our powers and duties in our responsibility to the Territory's community and farmers. We fulfill our mission and responsibilities through our operational divisions, including Food Production; Marketing; Agricultural Development; Abattoir Services; Veterinary Services; Administration and Management; Forestry; and the Industrial Hemp Program.

DEPARTMENTAL VACANCIES

The Department of Agriculture currently has 18 vacant positions which cover a range of critical needs of the agency across all divisional units. We are actively and strategically taking steps to fill all vacancies. We recently filled four vacancies for the position of laborer and we are currently preparing to interview candidates for the positions of butcher and heavy equipment operator. Our management team continues to diligently advertise and seek a suitable candidate for the critical position of State Veterinarian. Additionally, in preparation for negotiations with employee unions, we are currently engaged with the Office of Collective Bargaining to address staff salary increases. A complete list of our vacancies is provided in Attachment A.

In support of the approved USVI Agricultural Plan, we have identified a Local Farm and Food Coordinator. Our administrative team is actively working to hire this new employee who will coordinate the activities of the Local Farm and Food Council.

INVENTORY AND CONDITION OF EQUIPMENT

The Department of Agriculture's inventory of heavy equipment is used in support of farmers, to assist other agencies, and provide emergency response assistance as necessary. Therefore, it is critical for the VIDA to always maintain a fully functional fleet of heavy equipment. Attachment

B provides a listing of our machinery and their condition at present. Some equipment require minor repairs while some require major upkeep. In other instances, our mechanics recommend the replacement of dilapidated equipment.

On St. Croix, the most urgent need is the procurement of two additional tractors and a compliment of tractor implements to increase our level of support to farmers and agricultural productivity. Of course, this increase in inventory must be accompanied by an increase in the number of heavy equipment operators. As mentioned previously, we are presently preparing to interview candidates for the position of heavy equipment operator. Simultaneously, we are preparing to purchase some of the additional needed heavy equipment for both districts.

On St. Thomas, repair work is almost completed for all three machines in our inventory. We are in the final phase of procuring a new water truck for the St. Thomas/St. John District. We anticipate receiving the new water truck once the final payment is received by the vendor. In addition, we are planning to procure a new skid steer and some implements to conduct various tasks, including land preparation for farmers. Through a grant award from the U.S. Department of Interior, our agency was able to secure funding for the purchase of a front end loader machine which will be used for land preparation projects on behalf of farmers.

STATUS UPDATE ON LEASE AGREEMENTS FOR FARMERS

The VIDA has a total of forty (40) expired lease agreements for farmers on St. Thomas and ten (10) for farmers on St. Croix. Of this total number of expired lease agreements, 8 are being processed for renewal. However, only two (2) may be executed due to challenges with securing liability insurance coverage. The two farmers whose lease agreements are being processed hold

umbrella type insurance coverages for other business ventures which satisfy the needs of the lease agreement. The management team of the VIDA continues to communicate and work with the team at the Department of Property and Procurement and local insurance companies to address this important concern.

The VIDA has developed an internal process to categorize all lease documents after evaluating them on a case-by-case basis. Based on this system in the St. Thomas/St. John District 18 leases are recommended for renewal, 10 for non-renewal, and 12 for probationary renewal. In the St. Croix District we have a total of 149 active leases and land use permits. Of this total

83 of the expired leases are recommended for renewal, 30 for non-renewal, and 24 for probationary renewal.

The final category of farmer applicants includes those for whom agreements cannot be initiated due to the lack of a survey map for the property under consideration for leasing. Our management team will allot a portion of our current budget to address land survey needs in both districts.

Attachment C provides information regarding the lease agreements managed by the VIDA.

STATUS UPDATE ON GRANTS ISSUED TO THE VIDA

The Department of Agriculture is currently implementing a wide range of grant funded projects through our Marketing, Administrative, Veterinary Service, and Forestry Divisions. In the Marketing area, the WIC Farmers' Market Nutrition Program connects young mothers and their

families with farmers who provide them with fresh farm products. The program also provides payments to participating farmers through a coupon distribution system. A portion of the Specialty Crop Block Grant Program funds is sub-awarded to the UVI School of Agriculture to support projects that address the needs of local farmers.

Some of the grant funding received by the Veterinary Services Division is used for the purpose of supporting local surveillance efforts to monitor and control the spread of the Bont Tick, an economically important pest on cattle. Presently, our staff is diligently monitoring the spread of the bont tick which negatively impacts livestock health, and economic return for farmers. Other funding is used to establish and implement disease traceability protocols.

The Administrative Team manages FEMA grant funds that have been secured for the purpose of constructing the new VIDA Administration Building on St. Croix, and the repair of damaged livestock enclosures. The opening date to receive bids for the construction of the new administrative building is March 21, 2024. A contractor has been identified for the pig pen repair project; a contract is being drafted and awaiting execution. The majority of the FEMA funded projects in the St. Croix District have been completed.

Other FEMA funding is actively supporting a project to establish a temporary modular office space for VIDA staff on St. John, the repair of a farm access road in Estate Dorothea (St. Thomas), repairs to the Bordeaux Farmers' Market, and the fencing, greenhouse, and ancillary building in Estate Dorothea (St. Thomas). These projects resulted from damage caused by the 2017 hurricanes.

Funds received from the National Association of Conservation Districts are used for training and to promote educational projects that advance the conservation of our natural resources. The remainder of the funding received from the Department of Interior are currently being obligated to improve the water distribution system for farmers in Estate Bordeaux.

The Forestry Division has three subsections – Urban and Community Forestry, Forest Legacy, and Forest Stewardship. The funds received through Urban and Community Forestry are used to support a variety of projects that promote education and awareness of the importance and care of trees in urban areas. The Forest Legacy funds can be used for the purpose of purchasing real property while the Forest Stewardship Program funds are used for the purpose of developing management plans for the care and preservation of the natural forests of the territory.

STATUS UPDATE ON ST. CROIX ABATTOIR

The St. Croix abattoir is our single most important and vulnerable facility at the VIDA. We continue to face issues pertaining to our inventory of outdated equipment. The renovation, which is in progress, targets the three routine weak points of the system – the boiler, chill room, and the rumping station. We are in the process of procuring a new boiler and rumping station which will be shipped to the territory once pending payments are received. ARPA funding awarded by the Office of the Governor will be used to complete all necessary renovations of the St. Croix abattoir.

In the case of the St. Thomas abattoir, ARPA funding awarded by the Office of the Governor have been identified for the purchase of a new mobile abattoir facility which will be USDA

approved and consistent with industry standards. Our office is currently working with the Office of Management and Budget to access the ARPA funds.

LIST OF LICENSED FARMERS

Based on the information received from the DLCA there is currently a total of 251 licensed farmers in the territory,7 on St. John, 204 on St. Croix, and 40 on St. Thomas. As mentioned during previous senate hearings, based on our recent review of the list of licensed farmers, some of the license holders are actually home gardeners who produce fruits and vegetables for domestic consumption, but not commercially. While we strongly encourage and support all home gardening efforts, licenses should be awarded to commercial producers of crop, livestock, honey, and other commodities. Based on this, the VIDA is working to educate all home gardeners regarding our requirements for the renewal of their licenses. A complete list of the current licensees is provided as Attachment E.

Regarding the numerous challenges faced by the VIDA and the farming community, we have developed an extensive plan to address all areas of concern, including infrastructure, production, marketing, training, and outreach. This comprehensive plan has been approved by the Office of the Governor with monetary support in the amount of \$10,000,000.
