



## SUPPLEMENTAL CONSTRUCTION CONTRACT

THIS AGREEMENT is made this 25th day of July, 2022, in the Territory of the Virgin Islands, by and between the Government of the Virgin Islands, Department of Property & Procurement, on behalf of the Virgin Islands Department of Education (hereinafter referred to as "Government") and Professional Design/Builders, Inc., d/b/a Custom Builders (hereinafter referred to as "Contractor").

#### WITNESSETH:

WHEREAS, the parties entered into a contract for the Modernization/Renovation of the Glady's Abraham Elementary School on the island of St. Thomas, Virgin Islands, Original Contract No. C021DOET20 (CB), dated March 1, 2021, a copy of which is attached and incorporated herein by reference; and

WHEREAS, the Government is desirous of Additional Work for the Modernization/Renovation of the Glady's Abraham Elementary School on the island of St. Thomas, Virgin Islands which are more particularly described in Supplemental Addendum I (Supplemental Scope of Work), Supplemental Addendum II (Supplemental Compensation), incorporated herein by reference and made a part of this supplemental construction contract; and

WHEREAS, these services are an integral and functional part of the Modernization/ Renovation of the Glady's Abraham Elementary School on the island of St. Thomas, Virgin Islands for the betterment of services to the public and working conditions in general; and

WHEREAS, the Contractor is willing and capable of providing such services.

NOW THEREFORE, in consideration of the mutual covenants herein contained, and intending to be legally bound by this written instrument, the parties hereto do covenant and agree as follows:

#### 1. SERVICES

The Contractor will provide the services described more particularly in Supplemental Addendum I (Supplemental Scope of Work) incorporated herein by reference and made a part of this construction contract.

#### 2. TERM

This Contract shall commence upon execution by the Governor of the United States Virgin Islands and shall terminate within **One Hundred Twenty** (120) calendar days from the issuance of the formal Notice to Proceed, or in accordance with an agreed upon extension pursuant to the General Provisions.

#### 3. COMPENSATION

The Government, in consideration of satisfactory performance of the services described in Supplemental Addendum I, agrees to pay the Contractor the sum of Three Million, Twenty-Nine Thousand Six Hundred Sixty Dollars and Ten Cents (\$3,029,660.10), in accordance with the provisions set forth in Supplemental Addendum II (Compensation), attached hereto is hereby incorporated by reference and made a part of this contract.

#### 4. LIQUIDATED DAMAGES

It is hereby expressly agreed by the parties hereto that in the event the Contractor has not completed the scope of work under the term set forth in Paragraph 2 hereof, **Three Hundred Dollars** (\$300.00), for each calendar day or portion thereof shall be due the Government. The liquidated damages shall first be deducted from any contract monies due, but not yet paid to the extent available.

#### 5. EFFECTIVE DATE


The effective date of this Contract is upon the execution by the Governor of the United States Virgin Islands.

#### 6. FALSE CLAIMS

Contractor warrants that it shall not, with respect to this Contract, make or present any claim upon or against the Government of the Virgin Islands, or any officer, department, board, commission, or other agency thereof, knowing such claim to be false, fictitious or fraudulent. Contractor acknowledges that making such a false, fictitious, or fraudulent claim is an offense under Virgin Islands law.

#### 7. DEBARMENT CERTIFICATION

By execution of this contract, the Contractor certifies that it is eligible to receive contract awards using federally appropriated funds and that it has not been suspended or debarred from entering into contracts with any federal agency. The Contractor shall include this provision in each of its subcontracts hereunder and shall furnish its subcontractors with the current "LIST OF PARTIES EXCLUDED FROM FEDERAL PROCUREMENT OR NON PROCUREMENT." In the event the Contractor or any subcontractor misrepresents its eligibility to receive contract awards using federal funds, the Contractor or subcontractor agrees that it shall not be entitled to payment for any work performed under this contract or any subcontract and that the Contractor or subcontractor shall promptly reimburse the Government of the Virgin Islands for any progress payments heretofore made.







#### 8. NOTICE OF FEDERAL FUNDING

Contractor acknowledges that this Contract is funded, in whole or in part, by federal funds. Contractor warrants that it shall not, with respect to this Contract, make or present any claim knowing such claim to be false, fictitious, or fraudulent. Contractor acknowledges that making such a false, fictitious, or fraudulent claim is a federal offense.

#### 9. DAVIS BACON ACT

Contractor hereby agrees that it shall comply with all rulings and interpretations of the Davis-Bacon Act (40 USC 276a-5) and that the contractor and subcontractor agrees that all employees shall be paid the local prevailing wages as established by Virgin Islands statutes and laws.

#### 10. INSURANCE


Contractor shall maintain the following insurance coverages during the term of this Contract

- (a) COMMERCIAL GENERAL LIABILITY: Commercial general liability insurance, in a form acceptable to the Government, on a "per occurrence" basis with a minimum limit of not less than one million dollars (\$1,000,000.00) for any one person per occurrence for death or personal injury and one million dollars (\$1,000,000.00) for any one occurrence for property damage. Insurance policy(ies) shall name the Government of the Virgin Islands as the certificate holder and additional insured via an endorsement.
- (b) WORKERS' COMPENSATION: Contractor shall supply current coverage under the Government Insurance Fund or other form of coverage.

#### 11. PAYMENT AND PERFORMANCE BONDS

The Contractor shall comply with the following minimum bonding requirements:

- (a) A performance bond to secure Contractor's obligations and performance under the contract for 100% of the Contract price; and
- (b) A payment bond to assure payment to all persons supplying labor and material in the execution of the work provided for in the contract for 100% of the Contract price.







## Supplemental Addendum II

#### Supplemental Compensation

The Government, in consideration of the satisfactory performance of the services described in Supplemental Addendum I (Supplemental Scope of Work), agrees to make progress payments based on the Schedule of Values and invoices submitted by the Contractor, **Professional Design/Builders**, Inc., d/b/a Custom Builders in accordance with Clause 7 (Payments to Contractor) of the General Provisions.

The parties agree that the sum to be paid under this contract is **Three Million Twenty-Nine Thousand Six Hundred Sixty Dollars and Ten Cents** (\$3,029,660.10). The parties further agree that payments will be made in accordance with <u>services rendered</u>.

The final payment is subject to the inspection and acceptance of the project by the Government, the submission of all pertinent warranties, and the Release of Claims. Contractor shall submit a Waiver of Liens or Affidavits of subcontractors who have released the contractor of its obligations. Contractor shall also submit Consent of Surety before final payment and, upon the Government's request, any other documentation the Government deems necessary.
