There are several areas of the Bill that I would like to highlight because it would make the experience for child victim/witnesses less traumatizing.

- Allowing the child victim's testimony to be taken in a room other than
 the court room and to be televised by two-way closed-circuit television.
 This allows a reduction in trauma exposure. Child victims must cope
 with not only the emotional consequences of criminal acts but also with
 the potentially traumatizing effects of the legal system.
- 2. Closing the court room: This allows the judge to close the court room to the public as this would be in the best interest of the child victim if they must testify in open court. Currently, the court is open to the public. Testifying in open court can cause substantial psychological harm to the child victim. Some child victims are already suffering from (PTSD) Post-traumatic stress disorder. According to National Center on PTSD, ninety percent of all children who are sexually assaulted will develop PTSD and this can prevent the child from testifying. Some signs of PTDS are unexpected anger, volatile outburst, inability to focus or function at home and school as well as sleep disorders.
- 3. Use of Multidisciplinary Child Abuse teams (MDT): We already have a St. Croix MDT in place, this bill would allow another team to be established on St. Thomas/St. John as well. The team is made up of professionals from the public and private sector who work together in the best interest of the child victims. These types of teams are established all over the country to help the child victims and their families through the legal system with the least amount of harm and a great deal of support.

This Bill was created by Senator Angel Bolques, Jr. and his Staff and we all will be eternally grateful for what he is trying to do to save our children and hold the penetrators accountable for the criminal acts committed against our children.

We who work with child victims and their families will have more to work with having these safeguards to protect them in this Bill.
