## **SECTION 3. Establishment of a Police Impound Lot**

- The Virgin Islands Police Department shall establish an impound lot for the purpose 2 (a)
- of securely storing motor vehicles that have been towed for traffic violations, traffic accidents, 3
- impeding traffic on Virgin Islands roadways, or probable cause of criminal activity. 4

3		(1) Implementing strict safety and security protocols for impounded vehicles and

13	(c)	The Virgin Islands Police Department may charge an administrative fee in addition
14	to the fees	charged for the towing and storage of the impounded vehicle. All administrative
15	fees, and to	owing and storage fees must be imposed on the registered owner of the motor vehicle.
16	(d)	The registered owner of the vehicle shall be provided immediate notice of the
17	impoundm	ent and advised of the right to request a hearing before the Commissioner within 30
18	days of the	e impoundment.
19	(e)	Any fee adjustments must be approved by the Governor with the approval of the
20	Legislatur	e of the Virgin Islands.
21	(f)	Definitions.
22	For	purposes of this section, motor vehicle includes all-terrain vehicles and dirt bikes.
23		(1) "All-terrain vehicle" means a motor vehicle designed to travel over any

1	(g) Initial Fees.
2	The initial fees to be charged upon the establishment of the impound lot are as follows:
3	(1) Towing: \$65.00
4	(2) Storage: \$35.00 per day
5	(3) Administrative cost: \$25.00
6	SECTION 4. (a) The following allocations shall be made from the proceeds of traffic fines
7	imposed pursuant to title 20 Virgin Islands Code, chapter 43, section 512:
8	(1) One dollar from each paid traffic citation shall be transferred to the Superior
9	Court of the Virgin Islands for administrative purposes;
10	(2) Two dollars of every paid fine shall be allotted to the issuing law enforcement
11	agency; and
12	(3) An appropriation of \$5.00 per each paid citation shall be made to the Police
13	Athletic League program to enhance community engagement and youth programs; and
14	(b) The \$25.00 administrative fee imposed under section (3) shall be utilized solely for
15	the maintenance and upkeep of the impound lot.
16	SECTION 5. Effective Date
17	This Act takes effect thirty working days after enactment, and the fee allotments shall become
18	available to the entities identified in Section 4 effective October 1, 2025.
19	BILL SUMMARY
20	This bill amends Title 20, Virgin Islands Code, part II, chapter 43, section 512 increasing
21	penalties for traffic violations. It also allots funds to the Superior Court and issuing law
22	enforcement agencies apart from The Virgin Islands Police Department. Additionally, this bill
23	also makes an appropriation to support the Police Athletic League.
