An Act approving the Lease Agreement between the Government of the Virgin Islands, acting through its Commissioner of the Department of Property and Procurement, and Suntech Group, Inc. d/b/a St. Thomas Gas for Parcel No. 4 Submarine Base, No. 6, Southside Quarter, St. Thomas, Virgin Islands, consisting of approximately 27, 732.393 U.S. sq. ft. or 0.637 U.S. acre as shown on P.W.D. File No. D9-1426-T78 to be used for the purpose of operating a trucking, transportation, delivery, and retail business of bottled propane gas, and for no other purpose

- WHEREAS, on October 5, 2022, the President of Suntech Group, Inc. d/b/a St. Thomas
- 2 Gas, executed the Lease Agreement between the Government of the Virgin Islands and Suntech
- 3 Group, Inc. d/b/a St. Thomas Gas;
- WHEREAS, on November 3, 2022, the Commissioner of the Department of Property
- 5 and Procurement executed the Lease Agreement between the Government of the Virgin Islands
- 6 and Suntech Group, Inc. d/b/a St. Thomas Gas;
- 7 **WHEREAS**, on November 30, 2022, the Acting Governor of the Virgin Islands approved
- 8 the Lease Agreement between the Government of the Virgin Islands and Suntech Group, Inc.
- 9 d/b/a St. Thomas Gas;

- WHEREAS, Suntech Group, Inc. d/b/a St. Thomas Gas, will be leasing Parcel No. 4
 Submarine Base, No. 6, Southside Quarter, St. Thomas, Virgin Islands, consisting of
- approximately 27, 732.393 U.S. square feet or 0.637 U.S. acres, more or less, as shown on
- 4 P.W.D. File No. D9-1426-T78; for an initial term of 10 years, with two 5-year options to renew;
- 5 at an initial annual rent of \$54,000.00, payable in monthly instalments of \$4,500.00, to be used
- 6 for the purpose of operating a trucking, transportation, delivery, and retail business of bottled
- 7 propane gas, and for no other purpose;
- 8 WHEREAS, rent after the first year and every year thereafter, including the renewal
- 9 terms, will be adjusted in accordance with the Consumer Price Index, but no adjustment in
- 10 rental for any given year will increase by more than three percent over the preceding year
- 11 period; and
- WHEREAS, title 31 Virgin Islands Code, chapter 21, section 205, subsection (c)
- provides that in addition to the Governor's approval of any lease, the Legislature of the Virgin
- 14 Islands must also approve all leases that exceeds a term of one year; Now, Therefore,
- 15 Be it enacted by the Legislature of the Virgin Islands:
- **SECTION 1.** Pursuant to title 31 Virgin Islands Code, section 205, subsection (c), the
- 17 Legislature of the Virgin Islands approves the Lease Agreement between the Government of
- 18 the Virgin Islands, acting through its Commissioner of the Department of Property and
- 19 Procurement and Suntech Group, Inc. d/b/a St. Thomas Gas, for Parcel No. 4 Submarine Base,
- No. 6, Southside Quarter, St. Thomas, Virgin Islands, consisting of approximately 27,732.393
- 21 U.S. sq. ft. or 0.637 U.S. acre, more or less, as shown on P.W.D. File No. D9-1426-T78; for an
- 22 initial term of 10 years, with two 5-year options to renew, to be used for the purpose of operating
- a trucking, transportation, delivery, and retail business of bottled propane gas, and for no other
- 24 purpose.
