An Act honoring and commending Ralph A. deChabert, M.D. for outstanding contributions in the medical field to the people of the Virgin Islands and his many civic contributions to the community, especially to the island of St. Croix and to name the Labor and Delivery/Post Partum Unit "Maternity Services" at the Juan F. Luis Hospital and Medical Center North in his honor

- WHEREAS, Ralph A. deChabert was born on July 6, 1930 as the oldest child of Ralph
- 2 Demain and Ansetta "Annie" deChabert; and
- WHEREAS, Ralph A. deChabert grew up and went to school in Christiansted, St. Croix
- 4 where he attended the St. Mary's Grammar School and the Christiansted High School which
- 5 had an integrated junior high school; and
- 6 WHEREAS, Ralph A. deChabert after graduating from high school, attended and
- 7 graduated from New York University in 1954; and
- 8 WHEREAS, after graduating from New York University Ralph A. deChabert completed
- 9 two years of medical school in Toulouse, France; and

- WHEREAS, Ralph A. deChabert studied for three years at, and graduated from the
- 2 University of Lausanne's School of Medicine in Switzerland in 1959 with a Medical Degree
- and earned the right to affix the initials "M.D." after his name; and
- 4 WHEREAS, when Ralph A. deChabert attended the University of Lausanne's School of
- 5 Medicine, his medical school roommate was Bradford Marshall now deceased; and
- 6 WHEREAS, Dr. deChabert met Dr. Wook Suh during his first year of OB-GYN
- 7 residency at Harlem Hospital; and
- 8 WHEREAS, Dr. deChabert, met Dr. Jose Poblete during the second and third year of his
- 9 OB-GYN residency at Sydenham Hospital; and
- WHEREAS, Dr. deChabert completed a Obstetrics and Gynecology residency at Harlem
- Hospital in New York in 1962; and
- WHEREAS, both Sydenham Hospital and Harlem Hospital are within the New York
- 13 City Hospital System; and
- WHEREAS, in 1963, Dr. deChabert became an Obstetrics and Gynecology practitioner
- in St. Croix; and
- WHEREAS, on June 27, 1964, Dr. deChabert married the beautiful and kind Mildred
- 17 "Millie" Cecilia Amritt-de Chabert (deceased); and
- WHEREAS, Danielle E. deChabert, RPh and Gisele F. deChabert, Esq., are the children
- of Dr. and Mrs. deChabert; and
- WHEREAS, Danielle deChabert, RPh is a licensed pharmacist at the Governor Juan F.
- 21 Luis Hospital and Medical Center; and
- 22 WHEREAS, Gisele deChabert practices real estate law with the Rockefeller Group in
- New York, New York; and
- WHEREAS, Dr. deChabert and his siblings (Rita deChabert-Schuster, Attorney Mario
- N. deChabert (deceased), Austin deChabert (deceased), and Shirley deChabert-Highfield,

- 1 Ph.D.) were the members of Esperanza Development Corporation and Sunny Isles Shopping
- 2 Incorporated; and
- 3 WHEREAS, Dr. deChabert was an integral part of the Esperanza Development
- 4 Corporation which constructed, owned, and operated the Sunny Isles Shopping Center on St.
- 5 Croix, Virgin Islands; and
- 6 WHEREAS, Dr. deChabert was the president of Esperanza Development Corporation
- 7 and Sunny Isles Shopping Center Incorporated; and
- 8 WHEREAS, Sunny Isles Shopping Center Incorporated donated No. 6 Estate Diamond,
- 9 Christiansted, St. Croix, a 17-acre plot of land to the Virgin Islands Government for the
- 10 construction of a new hospital on St. Croix Hospital; and
- WHEREAS, the St. Croix Hospital opened in October 1982 and replaced the Charles
- 12 Harwood Hospital; and
- WHEREAS, Rita deChabert-Schuster, sister of Dr. deChabert served as a member of the
- St. Croix Government Hospital Facilities Board of Trustees from June 1996 to June 1999; and
- WHEREAS, the name of the St. Croix Hospital and Medical Center, was changed to the
- "Governor Juan F. Luis Hospital and Medical Center" with the enactment of Act No. 5876 on
- 17 July 19, 1993; and
- WHEREAS, the St. Croix District Governing Board adopted a resolution on April 19,
- 19 2002 that named the Governor Juan F. Luis Hospital Dialysis Unit in honor of Mrs. Ansetta
- 20 "Annie" deChabert and Attorney Mario N. deChabert to recognize their contributions to the
- 21 development of the unit; and
- WHEREAS, the same resolution also named the Labor & Delivery Unit in honor of Dr.
- 23 deChabert for his professionalism, dedication, and commitment to patients in the St. Croix
- 24 Community; and

- 1 WHEREAS, Dr. deChabert's nephew, Troy A. Schuster-deChabert, was Acting
- 2 Chairman of the St. Croix District Governing Board with jurisdiction over the Governor Juan
- 3 F. Luis Hospital and Medical Center from September 9, 2014 to October 3, 2015; and
- 4 WHEREAS, Mr. Schuster-deChabert became chairman of the St. Croix District
- 5 Governing Board from November 3, 2015 to April 1, 2018; and
- 6 WHEREAS, Dr. deChabert was Chief of the Department of Obstetrics and Gynecology
- 7 at the Charles Harwood Hospital and the Governor Juan F. Luis Hospital and Medical Center
- 8 from 1963 until 2000; and
- 9 WHEREAS, Dr. deChabert maintained continuous OB-GYN services at the Governor
- Juan F. Luis Hospital and Medical Center when St. Croix was being ravaged by Hurricane
- Hugo, a Category 4 Hurricane, on September 17, 1989; and
- WHEREAS, for more than one year after Hurricane Hugo ravaged St. Croix, Dr.
- deChabert provided medical services to expectant mothers in U.S. Military-deployed medical
- units, a/k/a "DEP-MEDS"; and
- WHEREAS, Dr. deChabert presented at and hosted Continuing Medical Education
- conferences for the Obstetrics and Gynecology Department; and
- WHEREAS, Dr. Ralph A. deChabert was in private practice with Dr. Manuel Camoes
- 18 (deceased) and Dr. Ernest Batenga (deceased) at Island Medical Center in Sunny Isles on St.
- 19 Croix; and
- WHEREAS, Dr. Jose Poblete (a retired surgeon and a former VI Commissioner of
- 21 Health), Dr. Wook Suh (a retired surgeon), the late Dr. Bradford Marshall (a physiatrist), the
- 22 late Dr. Claudius Henry (an orthopedic surgeon), the late Dr. Warrren Briscoe (an obstetrician-
- 23 gynecologist), Dr. Cheryl Wade (a retired surgeon), Dr. Michelle Berkeley (an obstetrician-
- 24 gynecologist), and Dr. Angelo K. Galiber (a diagnostic radiologist) are some of the exceptional

- 1 physicians whom Dr. deChabert recruited to work in St. Croix, United States Virgin Islands;
- 2 and
- WHEREAS, Dr. deChabert was the Director of the Virgin Islands Drug Rehabilitation
- 4 Program from the 1960s until 1975; and
- 5 WHEREAS, Dr. deChabert was the Assistant Commissioner of Health from 1973 to
- 6 1976; and
- WHEREAS, Dr. deChabert was the Medical Director of Charles Harwood Hospital from
- 8 1973 to 1976; and
- 9 WHEREAS, Dr. deChabert was a St. Croix District Governing Board member from
- 10 January 28, 1993 to January 27, 1995; and
- WHEREAS, Dr. deChabert was the Virgin Islands Medical Society's 1995 Physician-
- 12 Of-The-Year; and
- WHEREAS, on June 8, 2002, the Governor Juan F. Luis Hospital and Medical Center
- administration honored Dr. deChabert at its 3rd annual ball; and
- WHEREAS, Dr. deChabert delivered over 15,000 Crucian babies during his career; and
- WHEREAS, Dr. deChabert retired from hospital service and his private OB-GYN
- practice at the end of January 2004; and
- WHEREAS, Dr. deChabert has been a member of the Virgin Islands Medical Society in
- 19 good standing for many years; now therefore:
- 20 Be it enacted by the Legislature of the Virgin Islands:
- SECTION 1. The Legislature of the Virgin Islands, on behalf of the people of the Virgin
- 22 Islands, honors and commends Dr. Ralph A. deChabert for his distinguished obstetrics and
- 23 gynecology career and his major roles in the development of St. Croix health system.

SECTION 2. The Obstetrical and Gynecology Ward at the Governor Juan F. Luis 1 2 Hospital and Medical Center North is named "The Dr. Ralph A. deChabert Department of Obstetrics and Gynecology." 3 **SECTION 3.** The Commissioner of the Department of Health in conjunction with the 4 Commissioner of Public Works shall provide for the erection of appropriate signage in an 5 appropriate location at the Governor Juan F. Luis Hospital and Medical Center North. 6 7 **SECTION 4.** (a) The sum of \$10,000 is appropriated for the fiscal year ending September 30, 2023, from the General Fund to the Virgin Islands to the Department of Public 8 9 Works for the erection of signage for the purpose set forth in section 2. 10 (b) The sum appropriated in subsection (a) remains available until expended. **SECTION 5.** In recognition and appreciation of his contributions to the people of the 11 Virgin Islands, the President of the Legislature, or the President's designee shall have a perma 12 13 plaque copy of this act prepared and presented to Dr. Ralph A. deChabert, or his designee, at an appropriate ceremony. 14 **BILL SUMMARY** 15 16 Section 1 of this Bill honors and commends Dr. Ralph A. deChabert for his medical and civic contributions to the people of the Virgin Islands. 17 Section 2 names the Obstetrical and Gynecology Ward at Governor Juan F. Luis Hospital 18 and Medical Center North is named "The Dr. Ralph A. deChabert Department of Obstetrics 19 and Gynecology." 20 Section 3 of the bill directs the Commissioner of Health in conjunction with the 21 Commissioner of Public Works to erect the appropriate signage to commemorate the event. 22 Section 4 of the bill appropriates the sum of \$10,000 to fund the cost of the placement of 23
