## Thirty-Fifth Legislature of the Virgin Islands

A Resolution honoring and commending Music in Motion School of Higher Dance Education and its founder, Charlita Schuster, on the occasion of the  $40^{th}$  Anniversary of the establishment of the Music in Motion Dance Academy

- 1 **WHEREAS,** Music In Motion Dance Academy was established in 1983 on the island
- of St. Croix in the Virgin Islands;
- WHEREAS, at the age of 25, the founder, Charlita Schuster, made a bold decision to
- 4 move back home from New York to St. Croix and officially opened her dance school with a
- 5 total of five students;
- 6 WHEREAS, Music In Motion Dance Academy was later renamed Music in Motion
- 7 School of Higher Dance Education;
- 8 **WHEREAS,** the reason for the name change was that Ms. Schuster wanted to educate
- 9 the community that dance is an educational development, not just something fun to do;
- WHEREAS, Music In Motion School of Higher Dance Education was designed to train
- students in various dance styles, including classical ballet, modern, tap, Quadrille, African, and
- 12 Latin dance;

1	WHEREAS, Music In Motion School of Higher Dance Education orchestrates yearly
2	dance performances to showcase the technical skills students are taught during the year;
3	WHEREAS, Music In Motion School of Higher Dance Education has trained some of
4	the best classical ballet dancers, performers, and stage and movie entertainers, along with
5	skilled gymnasts and acrobatic tumblers on the island of St. Croix;
6	WHEREAS, Music In Motion School of Higher Dance Education students have traveled
7	to Denmark, Antigua, St. Martin, St. Kitts, and other Caribbean islands to perform;
8	WHEREAS, numerous students of Music In Motion School of Higher Dance Education
9	have gone on to prestigious institutions and won numerous international titles and awards for
10	the territory;
11	WHEREAS, students of Music In Motion School of Higher Dance Education pursued a
12	Bachelor of Fine Arts Degree in Dance and were accepted and trained at the Dance Theatre of
13	Harlem, the Alvin Ailey American Dance Theater, The Rock School of Dance, Ballet Florida,
14	and The Interlochen Center for the Arts;
15	WHEREAS, in 2005 Ms. Schuster received the "I'm Proud Award" for her professional
16	and artistic contributions to the young people of the St. Croix community from the Annual
17	Cruzan-Latin Caribbean "Pig Roast" Festival;
18	WHEREAS, in 2014 Music in Motion School of Higher Dance Education was
19	recognized by the 10 <sup>th</sup> Annual Cruzan-Latin Caribbean "Pig Roast" Festival & Domino
20	Tournament for its outstanding and excellent contribution to the youth and the St. Croix
21	community at large;
22	WHEREAS, in 2017 Ms. Schuster received the Vocational Service Award for the Rotary
23	Club of St. Croix for her high ethical standards and devotion to artistic expression;
24	WHEREAS, besides Music In Motion School of Higher Dance Education, Ms. Schuster
25	assisted the University of the Virgin Islands, Albert A. Sheen campus on St. Croix, and Orville

1	E. Keen campus on St. Thomas by developing the ballet syllabus and studio for the new
2	Bachelor of Fine Arts program;
3	WHEREAS, in June of 2023, Music In Motion School of Higher Dance Education wil
4	celebrate its 40 <sup>th</sup> Anniversary with a series of monthly events beginning in June 2023; and
5	WHEREAS, the Virgin Islands should commemorate the Music In Motion School of
6	Higher Dance Education's 40 <sup>th</sup> Anniversary as the founder continues to impact the territory
