I must say, that his dedication and service to the Virgin Islands and its people, has established a legacy in the history of the U.S. Virgin Islands that will be mentioned from generation through generations.

To conclude, I must again commend the 35<sup>th</sup> Legislature of the United States Virgin Islands for recognizing and honoring Former Governor Kenneth Ezra Mapp for his incomparable productive service of 40-plus years, he humbly dedicated to the U.S. Virgin Islands.
