

### 11. GOVERNMENT EXPERIENCE:

### a. <u>United States Peace Corps, 1968-1970:</u>

Peace Corps Volunteer in Ethiopia, taught in a village school and managed community development projects.

### b. <u>Unites States Senate Select Committee on Intelligence Activities, 1975-1976:</u>

Served as Special Assistant to the Chief Counsel, investigated CIA attempts to assassinate foreign leaders and FBI attempts to undermine the Civil Rights Movement. Drafted legislation, prepared Senators Church and Mondale for hearings, rendered legal opinions.

### c. <u>United States Attorney's Office, Washington, D.C., 1976-1981:</u>

Served as Assistant United States Attorney, elevated to Deputy Director of Superior Court Operations, then to top executive position as Executive Assistant to United States Attorney. Tried numerous trials in the District of Columbia and ultimately managed an office of approximately 160 federal prosecutors.

### d. U.S. Attorney's Office, Virgin Islands, 1981-1982:

Served as an Assistant United States Attorney, trying cases on St. Croix and St. Thomas.

### 13. QUALIFICATIONS:

I have extensive background as an attorney, having handled numerous cases as a prosecutor, a defense attorney, a civil attorney, and an appellate attorney. During my time with the United States Attorney's Office in Washington, D.C., I served as Deputy Director of Superior Court Operations and as Executive Assistant United States Attorney. In short, I have already gained experience managing the same type of office as the Virgin Islands Department of Justice.

In addition, I am very familiar with the Virgin Islands, its customs, and its legal system. I have been a member of the Virgin Islands Bar for more than forty (40) years and have tried cases in court before juries in more than a hundred (100) trials. I know the Territory's lawyers, its judges, and its legal procedures. The V.I. Bar last year awarded me its Winston Hodge Award, which is its highest honor.

Finally, I am in excellent health, and my wife of 37 years and I are looking forward for this opportunity to give back to the Virgin Islands that have meant so much to us.

### 16. HONORS AND AWARDS:

I graduated from Indiana University Summa Cum Laude, with honors in history, and was inducted into the Phi Beta Kappa Honor Society. At Harvard University, I was granted a Woodrow Wilson Fellowship, one of the University's highest scholarships. At Stanford University Law School, I helped draft the law school's Environment Law Handbook and received an award for that.

While an Assistant United States Attorney in Washington, D.C., I was twice awarded an honorary plaque for outstanding service. This past year, the Virgin Islands Bar Association selected me for its highest honor, the Winston Hodge Award. My rating with Martindale-Hubble, the national rating agency, is AV, which is the highest rating for ethical standards and preeminent legal ability.

When I was initially invited to serve with the United States Senate as Special Assistant to the Chief Counsel of the Senate Select Committee on Intelligence, Activities, I was required to pass one of the highest security levels in the government, known as COMINT, that would permit me to read and work with highly classified foreign security, CIA documents. I was thoroughly investigated and approved for COMINT clearance, which I received. This was in 1975.

In 1976, when I applied to the U.S. Attorneys Office in Washington, D.C., I again underwent an investigation and was approved.

In 1972, while at Stanford University Law School, I took part in a demonstration involving several thousand students demonstrating in support of civil rights and against the Vietnam War. Hundreds of us were arrested and charged with obstructing a public thoroughfare. I do not recall that any fines or punishments were imposed.

I informed the authorities of this incident when I applied for the security clearance described in No. 18, and none of them held this incident against me. In my capacity as an attorney, I represented Richa Kahn, who was Jeffrey Epstein's accountant in New York and who was one of two joint executors of Epstein's estate. The government dismissed its case against him. However, to avoid even the appearance of a potential conflict, I will recuse myself from any Epstein matters and will let my Chief Deputy determine who should handle them.

I represented Amos Carty in his recent case in which he was charged with economic crimes during his tenure as the local hospital's Counsel and CEO. The Virgin Islands Supreme Court totally vindicated Mr. Carty, finding that he had acted legally and in good faith. I understand that Mr. Carty is seeking restitution for his legal expenses from the hospital. Of course, I will recuse myself from this matter.

## As the Attorney General Nominee, my four priorities are:

- Increase the cooperation among the Territory's major law enforcement agencies, *i.e.*, the Attorney General's Office, the Unites States Attorney, the Virgin Islands Police Department, and the Superior Court.
- Reduce the Department of Justice's case load by culling stale cases, promoting early pleas, and expanding diversion programs to enable the prosecutors to have the time and resources to focus on the more serious offenses.
- 3). Put in place a modern case management system, which will facilitate acquisition of materials from the VIPD, alert prosecutors of due dates for motion response, etc.
- 4). Implement a trial training program.

I have already taken steps to implement these objectives, both in short and long term, by meeting with the VIPD Commissioner, the U.S. Attorney, several judges, and heads of all divisions in the Department of Justice.

### GORDON C. RHEA, ESQ. U.S. VIRGIN ISLANDS ATTORNEY GENERAL NOMINEE

### <u>BIO</u>

Gordon C. Rhea earned his B.A. Degree with honors from Indiana University, his Master's Degree from Harvard University, and his law degree from Stanford University Law School. He began his legal career in Los Angeles, where he defended complex criminal cases, and then moved to Washington, D.C., where he served as Special Assistant to the Chief Counsel of the Senate Select Committee on Intelligence Activities. His work there involved obtaining documents, deposing witnesses, writing reports, drafting legislation, and preparing Senators Church and Mondale for hearings. He played a major role in investigating and drafting the Senate Committee's reports on the CIA's attempts to assassinate Fidel Castro and the FBI's campaign to discredit Martin Luther King.

When the Committee completed its work, Mr. Rhea became an Assistant United States Attorney in Washington, D.C., where he worked for some five years prosecuting cases ranging from misdemeanors to first degree murders to complex white-collar indictments. He served as the office's Deputy Director of Superior Court Operations, overseeing all felony prosecutions in the District of Columbia, and as the Executive Assistant United States Attorney under United States Attorney Charles C. Ruff, with responsibility for coordinating local and Federal law enforcement agencies, reviewing and authorizing major local and Federal prosecutions, trying high-profile prosecutions in the nation's capital, and assisting in managing the nation's largest Federal prosecutor's office of over 160 civil and criminal lawyers.

In 1981, Mr. Rhea was appointed an Assistant United States Attorney in the U.S. Virgin Islands, where he prosecuted several high-profile murder cases and economic crimes. He was already familiar with the Virgin Islands, having received Peace Corps training on St. Croix in the summer of 1968, before serving as a Peace Corps volunteer in Ethiopia for two years. In 1982, Mr. Rhea and Attorney Thomas Alkon founded Alkon and Rhea, a prominent plaintiff's firm on St. Croix specializing in toxic tort litigation, product liability cases, and complex white collar criminal cases. Alkon and Rhea brought critical litigation against the Hess Oil refinery and the Martin Marietta bauxite refinery for toxic exposure to workers, including asbestos, heavy-metal catalysts, silica, solvents, and isocyanate paints. They also prosecuted ground-breaking product liability cases against automobile manufacturers for injuries caused by vehicle instability, firewall failures, and occupant protection failures; handled litigation involving airplane crashes, turbulence encounters, and a wide range of catastrophic worker related injuries; and served as co-counsel in litigation against Exxon, ESSO, and Texaco for contaminating the sole-source Tutu aquifer on St. Thomas with petroleum and chlorinated hydrocarbons. Mr. Rhea represented several businessmen in Federal criminal investigations by the Justice Department's Criminal Tax Division.

In sum, Mr. Rhea has extensive experience in civil, criminal, and appellate litigation, much of it in the Virgin Islands, where he has been a member of the bar for forty years. He has handled multiple high-profile cases in the islands and won the largest civil jury verdict ever rendered in the V.I. in a landmark case involving cancer deaths caused by cigarettes. This year, the Virgin Islands Bar Association granted Mr. Rhea its highest honor, the Winston Hodge Award. Moreover, he has extensive experience managing one of the nation's major legal agencies, the United States Attorney's Office in Washington, D.C.
