(a) Your attendance is required to give testimony on all matters relating to the status and timeline of the Paul E. Joseph Stadium project.

“Relating to” means pertaining to, on the subject of, embodying, reflective, referring to, mentioning, referencing, discussing, addressing, showing, demonstrating, constituting, or being factually or logically connected to referenced matter.

Your testimony must include the following:

- (a) Written statement outlining GEC, LLC’s role for the Paul E. Joseph Stadium project;
- (b) Detailed construction progress report for the last 10 years;
- (c) Details on the current construction phase and upcoming work to completion;
- (d) Original and current project timeline;
- (e) Listing of ALL change orders between 2014 to 2024 and financial impacts; and
- (f) Any outstanding issues impacting project delivery.

This subpoena is directed to you pursuant to the following provisions:

- (1) Section 6, subsection (g) of the Revised Organic Act of the Virgin Islands;
- (2) Title 2 Virgin Islands Code, chapter 1, section 3; and
- (3) Rule 308 of the Rules of the Thirty-Sixth Legislature of the Virgin Islands.


