## Stadium design plans and renderings

- See attached PDF folder Original Contract Design Some drawings are unavailable due to a ransomware breach of GEC's computer system that deleted all contract records prior to February 16, 2025. In spite of recovery efforts costing in excess of \$100,000 only a portion of GEC's emails were recovered and none of our contract records. All of the Files recovered from our emails are attached in this folder. DPW/SPR may have more drawings on file for the original Contract designs.
- See attached PDF folder Design as revised by Governor Mapp All of the Files recovered from our emails are included – see note above. DPW/SPR may have more drawings on file for the full construction set of Governor Mapp re-design.
- Design as revised by Governor Bryan as being used for construction These 100% construction, permitted, drawings are over 75 megabytes so I am asking Janis Persaud, GEC's Contract Administrator to share them via sharing on line.

# • Authorization for the removal and reuse of the stadium wall by GEC

- Change Order 1 to the Construction Contract contained the following language regarding Structures and Obstructions that specifically gave the Contractor the right to salvage the existing outfield wall and stadium lights and poles.
- All structures, fences, buildings, or encumbrances of any character, upon or within the limits of the Site, shall be carefully removed by the Contractor and disposed of as indicated on the Plans and Specifications or directed by the Government Engineer and/or the Owner's Representative. Any material so removed, with the exception of materials resulting from the demolition of the existing outfield wall and stadium lights and poles, that was added via Change Order 1, which the Government Engineer and/or the Owner's Representative may order salvaged shall be carefully stored and remain the property of the Government and may be used in the construction if so ordered.
