Please see below for the latest status regarding outreach and confirmations for the upcoming **CYASP hearing scheduled for June 11, 2025**, regarding the Paul E. Joseph Stadium Project:

Derek Gabriel – Commissioner, Department of Public Works

- I spoke with Mr. Gabriel directly at **340-344-6287** (personal cell).
