Good Afternoon, Senator Bolques and Mr. Wessel,

I'm writing to provide a brief recap of today's conversation regarding the CYASP hearing scheduled for **June 11, 2025**.

Mr. Wessel shared that he is currently coordinating with several key agencies involved in the Paul E. Joseph Stadium Project to ensure a unified approach before any formal testimony is presented. These agencies include:

- Department of Sports, Parks, and Recreation (user agency)
- Department of Public Works
- Department of Property and Procurement (property holder)
- Public Finance Authority (funding and oversight)
