## PUBLIC ADVISORY: WATER QUALITY ALERT AT PROSPERITY BEACH

The Department of Planning and Natural Resources (DPNR), through its Division of Environmental Protection (DEP), in coordination with the U.S. Environmental Protection Agency (EPA), responded to community reports of a suspected pollutant discharge coming from the vicinity of the Prosperity Farm and Distillery and flowing into the ocean across from Mahogany Road.

Following an investigation, DEP and Coastal Zone Management staff collected water samples from the affected runoff. Laboratory results confirmed that the beach area directly across from Prosperity Farm and Distillery does not meet established water quality standards and is currently unsafe for swimming or fishing.

As a precaution, DPNR advises the public to avoid recreational activities at this location until further notice. Exposure to waters contaminated by sewage, stormwater runoff, or excessive sargassum can pose serious health risks due to elevated levels of bacteria and other pollutants. Members of the public are urged to avoid areas that:

- Appear discolored
- Emit foul odors
- Contain large amounts of sargassum
- Are near drainage basins, guts, or puddles

DPNR will continue to monitor water quality and provide updates as necessary.

# Indicators: Enterococci

## What are enterococci?


Enterococci are bacteria that live in the intestinal tracts of warm-blooded animals, including humans, and therefore indicate possible contamination of surface waters by fecal waste. Sources of fecal indicator bacteria such as enterococci include wastewater treatment plant effluent, leaking septic systems, stormwater runoff, sewage discharged or dumped from recreational boats, domestic animal and wildlife waste, improper land application of manure or sewage and runoff from manure storage areas, pastures, rangelands and feedlots. There are also natural, non-fecal sources of fecal indicator

bacteria, including plants, sand, soil and sediments, that contribute to a certain background level in ambient waters and vary based on local environmental and meteorological conditions.

## EXHIBIT 2B-3

Enterococci are typically not considered harmful to humans, but their presence in the environment may indicate that other disease-causing agents such as viruses, bacteria and protozoa may also be present. These pathogens can sicken swimmers and others who use rivers and streams for recreation or eat raw shellfish or fish. Other potential health effects can include diseases of the skin, eyes, ears and respiratory tract. Eating fish or shellfish harvested from waters with fecal contamination can also result in human illness.

## What can enterococci tell us about the condition of water?

Enterococci are one of two fecal indicators addressed in the EPA's 2012 Recreational Water Quality Criteria recommendations for protecting human health in waters designated for primary contact recreational use. Significant amounts of enterococci in a water

body can negatively affect the recreational and economic value of the aquatic resource. When the amount of fecal bacteria exceed state or Tribal recreational criteria, this may result in beach closures, swimming and boating bans and closures of fishing and shellfishing areas.





**PROPOSED BY:** Senator Genevieve R. Whitaker

---

1       **WHEREAS**, on March 30, 2022, the Legislature of the Virgin Islands, in its regular  
2 session adopted Bill No. 34-0216; and

3       **WHEREAS**, section 2 of Bill No. 34-0216, amended title 29 Virgin Islands Code,  
4 subchapter I, section 225, paragraph (4), intending to allow for the construction of rum  
5 distilleries on agricultural lands; and

6       **WHEREAS**, on April 11, 2022, the Governor of the Virgin Islands, the Honorable Albert  
7 Bryan, Jr., signed Bill No. 34-0216 into law, which then became Act No. 8569; and

8       **WHEREAS**, citizens have submitted correspondence to the members of the Thirty-  
9 Fourth Legislature of the Virgin Islands demanding that government officials reverse the  
10 section 2 of Act No. 8569, which permitted rum distilleries to be constructed on agricultural  
11 lands and to revoke the permit that the Virgin Islands Department of Planning and Natural

1 Resources granted an applicant, on the basis that the distillery is proposed to be located across  
2 from family beaches and Mahogany Road, Frederiksted, St. Croix, and that citizens did not  
3 have the opportunity to express concern about the permit that because there were no public  
4 notices given or public hearings held regarding the granting of the permit, and that the  
5 Department of Planning and Natural Resources ignored environmental reports;

6 **WHEREAS**, the public interest in the having input in the consideration of the granting  
7 of the permit outweigh any deprivations the applicant may experience as a consequence of the  
8 repeal of section 2 of Act No. 8659; Now, Therefore,

9 ***Be it enacted by the Legislature of the Virgin Islands:***

10 **SECTION 1.** Section 2 of Act No. 8569 is repealed.

11 **SECTION 2.** Title 29 Virgin Islands Code, chapter 3, subchapter I, section 225,  
12 subsection (b), paragraph (4) is amended by adding “or rum distillation” at the end of the  
13 paragraph.

14 **SECTION 3.** Section 2 is effective retroactive to April 11, 2022.

## 15 **BILL SUMMARY**

16 Section 1 of this bill repeals the provisions that removes rum distillation from being  
17 included in the definition of agricultural processing plant. Section 2 excludes rum distillation  
18 from the definition of agricultural processing plant. Section 3 makes the section 2 retroactive  
19 to April 11, 2022.

## Virgin Islands People Protecting Places (VIPPP) PETITION TO PROTECT OUR FARMS, NEIGHBORHOODS, AND COASTAL WATERS

### OPPOSE BILL NO. 36-0211

To the Members of the Thirty-Sixth Legislature of the Virgin Islands:

We, the undersigned residents of the U.S. Virgin Islands, respectfully urge you to **VOTE NO** on **Bill No. 36-0211** as it is currently written.

This bill would:

- Let **microbreweries and microdistilleries** be treated as “agricultural processing”.
- Allow these uses as **conditional uses in A-1 and A-2 agricultural zones and R-1 and R-2 residential zones**.
- Tell agencies to write detailed rules for these facilities **after** they are already allowed in these areas.
- Devalue all Virgin Islands properties.

We are not against local craft beverages or small businesses. Our concern is where and how these industrial uses are placed, and the impacts we already know about from existing rum and spirits production on St. Croix.

We are especially concerned that:

- **Agricultural land should protect food.** A-1 and A-2 zones were created to preserve limited farmland. Allowing distilleries and breweries there makes it easier to shift land and infrastructure away from food production and raises costs for current and future farmers.
- **Distillery wastewater (vinasse) can seriously harm soil and coastal waters** if it is not properly treated and contained. Our experience on St. Croix already shows how serious distillery wastewater problems can be.
- **Rum fungus has already damaged homes, trees, cars, and road signs on St. Croix** near existing rum operations. Allowing new distillery uses in farm and residential areas risks spreading that same problem into more neighborhoods.
- **Commercial activities** in R-1 and R-2 zones will reduce the value of our properties, causing a negative impact on buyers and sellers and potentially limit financing options.
- **Safeguards are coming after, not before.** The bill opens new zones to these uses first, then calls for micro-distillery rules to be written later. Given what we already know, this is backwards.

We therefore ask the Legislature to:

1. **Reject Bill No. 36-0211 in its current form; and**
2. **Keep distilleries and breweries confined to appropriate industrial zones unless and until strong, transparent, enforceable protections are in place and fully resourced.**

Clean water, healthy soils, livable neighborhoods, and a secure food future are more important than rushing new industrial uses into our farms and residential communities.
