Joseph, Sr., Chairman of the 8 Homeland Security, Justice and Public Committee on 9 distinguished members of the 36th Legislature, legislative staff, ladies and 10 gentlemen in the chamber, members of the media, and our viewing and 11 listening audience. 12 13 My name is Gleston McIntosh, Jr., and I serve as the Executive Director 14 of the Virgin Islands Peace Officer Standards and Training Council (POST). 15 It is both an honor and a privilege to provide testimony today in support 16 of Bill No. 36-0136 an Act amending Title 23 of the Virgin Islands Code, 17 Chapter 17, Subchapter II, by adding new sections 1331 through 1336 18 to mandate lethal weapon training for private security guards and 19 investigators. 20 21 Importance of the Bill 22 Private security professionals are often the first responders to incidents 23 at businesses, schools, government facilities, and public events. They 24 frequently encounter threats before police arrive and must make critical, 25 split-second decisions that can affect lives. 26 27 28

Currently, unlike sworn peace officers who undergo rigorous POSTcertified academy training, private investigators and security guards who carry firearms are not held to the same standards. This creates a gap that puts both officers and the public at risk.

Bill No. 36-0136 closes this gap by establishing mandatory training, and certification programs in lethal weapon handling, law enforcement practices, and protection of citizens' rights all under the administration and oversight of the Commissioner of Police.

### By mandating lethal weapon training, it will:

- Ensure weapons are handled safely and responsibly.
- Reduce the likelihood of negligent discharges or unlawful use of firearms.
- Provide security professionals with training in de-escalation, decisionmaking under stress, and constitutional protection.
- Increase public trust that armed private security officers are properly vetted, trained, and certified.

# Clarification of "Investigator" Definition

It's also important that the law clearly defines who an "investigator" is, having a clear definition avoids confusion, supports proper enforcement, and keeps compliance and oversight consistent.

## **Recommended Training Components**

- The training program, to be administered under the Virgin Islands Police
- 55 Department (VIPD), should include:

- Firearms Proficiency & Safety, Proper Firearm Storage and a POST approved firearms qualification course.
- Use-of-Force & De-Escalation Force Continuum, Conflict Resolution,
  Decision Making Under Stress, and Crisis Intervention.
- Legal & Ethical Standards local and federal laws, detention and arrest
  authority and liability awareness.
- Scenario-Based Training Active Shooter Response, workplace violence, crowd management, and coordinated response with VIPD.
- Lifesaving Skills First Aid, CPR, and trauma response training. The
  inclusion of VIPD's Training Division in oversight will ensure
  consistency, accountability, and ongoing compliance.

### **Certification & Continuing Qualification**

- To maintain high standards, the legislation should require:
- Annual firearms qualification to ensure continued competency.
- Yearly refresher courses on use-of-force and Constitutional Updates.
- At least eight hours of continuing education annually in situational awareness, community engagement, and professional ethics.
- Consideration of physical and psychological fitness screenings to confirm readiness to safely carry a firearm.

# **Role of Law Enforcement in Implementation**

The Police Commissioner and Training Division must be directly involved in administering, monitoring, and enforcing training standards. Their leadership will guarantee proper certification, periodic review, and enforcement of compliance.
