President Potter and members of the Thirty-Sixth Legislature of the Virgin Islands:

I am writing today to express my unequivocal support for my friend and colleague Melanie Turnbull, Esq. to serve as a judge on the Superior Court of the Virgin Islands. I moved to the Virgin Islands more than 20 years ago to serve the People of the Virgin Islands as an attorney. Since moving to St. Thomas, I have served as coach in the Appellate Moot Court Competition for several years on behalf Charlotte Amalie High School. Additionally, I have served on the board for the Office of the Territorial Public Defender, and volunteered for the District Court's Criminal Justice Act Panel representing indigent defendants.

A large portion of my practice is dedicated to serving as defense counsel for persons charged with criminal offenses. In that capacity, I have gotten to know Attorney Turnbull and can attest to her integrity, intelligence, and dedication to the ideal of equal justice for all. Attorney Turnbull is well-respected by prosecutors, defense attorneys, judges and jurors.
