The circumstances that the Virgin Islands were placed in after Hurricane Maria was significant and detrimental, however the opportunity to take advantage was open and I decided to volunteer at Eulalie Rivera Elementary School as a Teacher's Assistant; while completing over 200 Hours in Community Service.

As in the Tenth Grade, I joined Jobs for America's Graduates and became the first person at the school to serve as President for two years, while being involved in Student Council and Change and Negotiate, and starting my CTEC Journey in the National Academy Foundation also known as NAF.

As I enrolled in NAF Hospitality and Tourism program, it first intrigued my interest after participating in a CTEC Fair at the Career and Technical Education Center on St. Croix. The Career cluster represented how I felt about my home and the positive impact I want to make and it was one of the best decisions I've ever made. While being enrolled, I learned basic and advanced skills in Event Planning, Principles of Tourism, Management, Business Law, Finance, Accounting, Leadership, Teamwork and Hard Work. This program also offered me the opportunity to intern at Manning Legal Services, which aligned with my career choice at the time, a lawyer or attorney.

Once confirmed, my target approach includes the following;

- 1. **Developing a Taskforce and or Committee with primary stakeholders,** the Virgin Islands Departments of Education and Labor, The Virgin Islands Boards of Education and Career and Technical Education, the University of the Virgin Islands, and The Workforce Development Board to **design a footprint** to ensure Technical students receive the same funding and real- world opportunities in the Virgin Islands.
- 2. To work with the Virgin Islands Department of Education and Board of Education to look at the current Electives and Courses offered at our K-8 and Junior High Schools to evaluate how these courses can be considered **prerequisites** before the students enroll into the programs at the High School level.
- 3. This also includes advocating for the Board of Education to ensure all public K-8 and junior high schools in the territory **offer at least three to four ongoing CTE-typed courses** to the students before High School.
- 4. To improve the Website's accessibility and modernization. As an independent government entity that requires teachers to visit our platform and the types of clusters that we represent, our website must reflect that core ideology and value. This goal also matches the recently passed legislation, The IDEA Act also known as Act 8857 which was sponsored by Senator Samuel Carrion in the 35th Legislature.
- To review the current structure of the Board and the schools and how we can institute the FARES Approach into the system. The FARES Approach stands for Fair Opportunity, Alignment, Retention, Employment and Sources.
- **Fair Opportunity** includes prioritizing the pay of our instructors depending on the course and experience in the career field. For most of the technical careers, a certification, ongoing professional development and years of experience should be required, the degree can be a bonus.

- Alignment includes looking at all current Career and Technical Education courses
  offered in the territory and adding courses that aligns with the current needs of the
  community to include Construction as recovery projects need to be completed.
  This also includes creating our own Government Internship Network, where students
  can complete internships in the Government relating to their fields of interest.
- Retention includes creating enticing benefits and agreements to assist with keeping
  instructors within the pool of educators. This also includes offering full ride scholarships
  to students and or certified citizens in the workforce to obtain the educational
  requirements and return to work for the Government for five years as a part of the
  agreement.
- Employment includes designing requirements that match the current pool of certified
  citizens who make up the private sector workforce, while affording opportunities for
  students to become apprentices immediately after High School and becoming eligible to
  teach after Five years of paid apprenticeship or real-world experience. This sector also
  includes creating a benefit packed campaign in partnership with the Virgin Islands
  Department of Education to encourage many in the United States to return home.
- Sources include providing oversight to ensure the proper resources for our students and educators are available at all schools teaching CTE Courses. This also includes advocating and pushing the Virgin Islands Department of Education to give funding to the schools to get the necessary equipment to train our students with 21st century tools.
- 6. To Work with the Department of Education and the Board of Education at the different institutions, analyze how we can introduce internships from the 11th Grade for certain courses, as some courses are required to have at least an actual year of internship, not school year.
- 7. To conduct **regular visits of all public schools** that provide Career and Technical Education courses to ensure the proper resources, spaces and equipment are provided to stimulate the best instruction and training for all courses. This also includes safety checks and monitoring of aging infrastructure, to ensure the High priority of safety and wellbeing for our students and educators.
