An Act honoring and commending the Eighth elected Governor of the Virgin Islands, Kenneth Ezra Mapp for his years of service to the people of the Virgin Islands and naming Route 75 on the island of St. Croix from Bassin Triangle intersection at Route 70, Estate Richmond and ending at Krausse's Lagune the "Gov. Kenneth E. Mapp Highway"; appropriating \$45,000 from the General Fund of the Treasury of the Government of the Virgin Islands to the Department of Public Works to implement the mandates of this Act, to bestow the Virgin Islands Medal of Honor on Kenneth Ezra Mapp and for other related purposes

1 WHEREAS, Kenneth Ezra Mapp was born on November 2, 1955, in Brooklyn, New 2 York to Albert Mapp and Vashti Hewitt Mapp of St. Croix, Virgin Islands; and 3 WHEREAS, in 1961, Kenneth E. Mapp moved to St. Croix with his maternal 4 grandmother, Almina Nicholas Hewitt, began his education at Christiansted Public Grammar 5 School in the first grade, and graduated from St. Croix Central High School in 1973; and 6 WHEREAS, Kenneth E. Mapp joined the Boy Scouts of America at age eleven, 7 achieving the rank of Life and the position of Junior Assistant Scoutmaster; and 8 WHEREAS, after graduating high school, Kenneth E. Mapp returned to Brooklyn where 9 he joined the New York City Police Department as a police trainee, formally titled, 10 "Community Service Officer" and graduated from the New York City Police Academy in May

1974; and

1	WHEREAS, upon graduating from the police academy, Kenneth E. Mapp was assigned
2	to the 83 rd Police Precinct in Brooklyn; and
3	WHEREAS, while at the New York City Police Department, Kenneth E. Mapp attended
4	New York City Community College of the City University of New York; and
5	WHEREAS, in 1977, the Virgin Islands Police Department recruited Kenneth E. Mapp
6	where he first briefly served as a school monitor, and then as a Virgin Islands Police Officer;
7	and
8	WHEREAS, Kenneth E. Mapp attended the University of the Virgin Islands and as a
9	police officer, served in the patrol division, the juvenile division, and as an Executive Security
10	Agent for Governor Juan F. Luis; and
11	WHEREAS, while a police officer, Kenneth E. Mapp was elected President of the Virgin
12	Islands Police Benevolent Association; and
13	WHEREAS, on November 2,1982, Kenneth E. Mapp was elected as a Senator in the
14	Fifteenth Legislature of the Virgin Islands; and
15	WHEREAS, in 1985, Kenneth E. Mapp was appointed Assistant Director of the
16	Industrial Development Commission, now the Economic Development Authority, and was
17	later nominated by Governor Juan F. Luis and confirmed by the Legislature to serve as the
18	Director of the Consumer Services Administration, now the Department of Licensing and
19	Consumer Affairs; and
20	WHEREAS, during his tenure as Director of the Consumer Services Administration,
21	Kenneth E. Mapp was a protagonist for enforcing food and medicinal standards, issuing
22	citations, and confiscating tens of thousands of food and medicinal items, some with expiration
23	dates beyond six years, and being sold as consumable products to Virgin Islands consumers;
24	and

1 WHEREAS, Kenneth E. Mapp attended a fellowship at Carnegie-Mellon University, 2 entitled, "Senior Executive Management" while serving at the Consumer Services 3 Administration; and 4 WHEREAS, in 1988, he was elected to the Eighteenth Legislature, and in 1992, he was 5 elected to the Twentieth Legislature of the Virgin Islands; and 6 WHEREAS, during his career, Kenneth E. Mapp was also employed in the private sector 7 at Abramson Enterprises, Inc. and at the Caribe Home Center, Inc. companies, both locally 8 owned and operated businesses; and 9 **WHEREAS,** in 1994, while serving in the Twentieth Legislature, Dr. Roy L. Schneider 10 selected Sen. Kenneth E. Mapp to be his running mate for Lieutenant Governor, both were 11 registered Republicans, but ran for office as independent candidates; and 12 WHEREAS, Dr. Roy L. Schneider and Sen. Kenneth E. Mapp were elected Governor 13 and Lieutenant Governor of the Virgin Islands of the United States in a runoff election on 14 November 22, 1994; and 15 WHEREAS, on January 2, 1995, Dr. Roy L. Schneider and Senator Kenneth E. Mapp 16 were inaugurated and took the oath of office to serve as Governor and Lieutenant Governor, 17 respectively; and 18 WHEREAS, during his tenure as Lieutenant Governor, Kenneth E. Mapp served as 19 Commissioner of Insurance and Chairman of the Virgin Islands Banking Board and was known 20 as an assiduous regulator of the banking and insurance industries, benefiting many banking and 21 insurance consumers; and 22 WHEREAS, while serving as Lieutenant Governor, Kenneth E. Mapp attended a 23 program at the Kennedy School of Government for senior executives in state and local 24 governments; and

1	WHEREAS, in 1997, the Kennedy School of Government at Harvard University offered
2	Kenneth E. Mapp a mid-career opportunity to pursue a graduate degree in public
3	administration; and
4	WHEREAS, Kenneth E. Mapp, not having attained an associate or bachelor's degree,
5	the Kennedy School of Government set specific criteria, including a commitment from him to
6	continue serving in the public sector as pre-conditions to his admittance into its graduate
7	school; and
8	WHEREAS, Lieutenant Governor Kenneth E. Mapp did not seek re-election to the office
9	of Lieutenant Governor; and
10	WHEREAS, in January 1999, following his tenure as Lieutenant Governor, Kenneth E.
11	Mapp, entered Harvard College and in July 1999, after achieving the enrollment requirements,
12	the Kennedy School of Government admitted Kenneth E. Mapp to its fall semester to pursue a
13	master's degree in public administration; and
14	WHEREAS, in 1999, Kenneth E. Mapp was honored by the St. Thomas / St. John
15	Historic Society for the accurate restoration of the edifice housing the Offices of the Lieutenant
16	Governor, known as Haggerman House, which was built in 1789 and is in Charlotte Amalie;
17	and
18	WHEREAS, on June 8th, 2000, Harvard University, the President, and Fellows of
19	Harvard College, acting on the recommendation of the Faculty of Government, John Fitzgerald
20	Kennedy School of Government, and with the consent of the Honorable and Reverend the
21	Board of Overseers, conferred the degree of Master in Public Administration on Kenneth Ezra
22	Mapp; and
23	WHEREAS, on June 8th, 2000, and Harvard College's three hundred and sixty-fourth
24	(364 th) year, it was noted that Kenneth E. Mapp was the third student since 1636 admitted to a

- 1 Harvard University graduate school and conferred a degree not having first attained an 2 associate or bachelor's degree; and 3 WHEREAS, in August 2000, Kenneth E. Mapp entered Harvard Business School and 4 completed the Advanced Management Program (AMP-159); and 5 **WHEREAS,** Kenneth E. Mapp is listed as an alumnus in good standing of the John F. 6 Kennedy School of Government and of Harvard Business School; and 7 WHEREAS, in March 2002, Governor Charles W. Turnbull, PhD appointed Kenneth 8 E. Mapp as the Director of Finance and Administration of the Virgin Islands Public Finance 9 Authority; and 10 WHEREAS, while serving at the Public Finance Authority, Kenneth E. Mapp raised 11 millions of dollars for a myriad of capital projects, including wastewater treatment facilities, 12 docks, road construction, school repairs, city and town improvements, sports and recreation 13 facilities, law enforcement equipment, and capital projects of nonprofit entities; and 14 WHEREAS, during his tenure at the Public Finance Authority, Kenneth E. Mapp raised 15 funds for, and managed Gov. Turnbull's historic restoration project, which included the Old 16 Danish School in Frederiksted built in 1799, the Peter von Scholten School in Estate Diamond 17 built in 1840, and "Quarters B" on Government Hill built in 1816; and 18 WHEREAS, Kenneth E. Mapp, while serving at the Virgin Islands Public Finance 19 Authority, also managed the development and/or construction of several major capital projects 20 including the creation and implementation of the Frederiksted Economic Revitalization 21 Project, renovation of the government owned Kings Alley hotel, modernization of the Ann E. 22 Abramson Marine Facility, the Vincent F. Mason, Sr. Coral Resort and Pool, the Verne I.
- Richards Veterans Memorial Park and the Paul E. Joseph Stadium; and

1 WHEREAS, while serving at the Public Finance Authority, Kenneth E. Mapp recovered 2 millions of dollars of investment losses (negative arbitrage earnings) and attained the 3 Authority's first investment grade ratings on Virgin Islands municipal securities; and 4 WHEREAS, Kenneth E. Mapp, as Director of Finance and Administration, raised 5 millions of dollars through the issuance of Private Activity Bonds for HOVENSA, the 6 territory's largest private sector employer, that assisted HOVENSA in refinancing its high 7 interest cost debt with the proceeds of the low interest Private Activity bonds, incurring no debt 8 obligation to the Government of the Virgin Islands; and 9 WHEREAS, Kenneth E. Mapp ran unsuccessfully for Governor in 2006 and again in 10 2010; and 11 WHEREAS, Kenneth E. Mapp and former Senator Osbert E. Potter campaigned as 12 independent candidates, and were elected Governor and Lieutenant Governor of the Virgin 13 Islands on November 18, 2014; and 14 WHEREAS, on January 5, 2015, Kenneth E. Mapp and Osbert E. Potter took the Oath 15 of Office to serve as Governor and Lieutenant Governor, respectively, making Kenneth Ezra 16 Mapp the eighth elected Governor of the Virgin Islands, Commander-in-Chief of the Virgin 17 Islands National Guard and a member of the National Governors Association; and 18 WHEREAS, Gov. Kenneth E. Mapp and Lt. Governor Osbert E. Potter assembled a 19 cadre of highly qualified professionals to serve in the Governor's cabinet and on their 20 respective staff; and 21 WHEREAS, in January 2015 at the behest of HOVENSA Gov. Kenneth E. Mapp met 22 with the principals of the company, which was indebted to the Government of the Virgin 23 Islands for more than \$60 million dollars for the suspension of HOVENSA annual payments 24 in lieu of property taxes (PILOT); and

1	WHEREAS, at the meeting, HOVENSA demanded the Government of the Virgin
2	Islands provide it with codified immunity against all claims, now and in the future, public or
3	private, in exchange for a one-time reduced payment of \$41 million dollars for the PILOT
4	owed; and
5	WHEREAS, in January 2015, Gov. Kenneth E. Mapp rejected HOVENSA'S demands
6	and directed the Attorney General of the Virgin Islands to begin immediate foreclosure
7	proceedings in the District Court of the Virgin Islands against HOVENSA, its refinery and all
8	related real property pledged as a surety against the suspension of HOVENSA'S payments in
9	lieu of property taxes; and
10	WHEREAS, in November 2015, HOVENSA and the Government of the Virgin Islands
11	reached a settlement agreement resolving the PILOT owed, HOVENSA'S environmental
12	damages and obligations to the territory and other related issues between both entities; and
13	WHEREAS, the settlement provided that HOVENSA pay the Government of the Virgin
14	Islands approximately \$265 million dollars, transfer to the Government ownership of real
15	property in Estates Pearl and Hope, appraised at \$655 million dollars, and mitigate its
16	environmental damages by fulfilling its corrective obligations to the territory; and
17	WHEREAS, under the agreement, the Government would release its liens against
18	HOVENSA'S remaining property and cooperate with HOVENSA on the sale of its refinery
19	and other properties; and
20	WHEREAS, in December 2015, Governor Kenneth E. Mapp called the Legislature into
21	special session to consider his proposed settlement with HOVENSA and a revenue sharing
22	agreement between the Government of the Virgin Islands and Arclight Partners, LLC, and
23	investment conglomerate, to purchase the HOVENSA refinery, and related assets; to authorize
24	the operation of an oil storage terminal facility and to pursue a restart of the oil refinery; and

1	WHEREAS, Gov. Kenneth E. Mapp worked with the Trump Administration, Arclight
2	Partners, LLC and Sinopec USA, Inc., the largest integrated oil company in China on the
3	successful oil refinery restart, creating thousands of employment opportunities; and
4	WHEREAS, Gov. Kenneth E. Mapp and his administration successfully raised salaries
5	in the public and private sectors by negotiating and implementing new wage agreements with
6	unionized government workers, setting a new base wage for public employees, and signing
7	legislation raising minimum wages in the private sector; and
8	WHEREAS, the Mapp-Potter administration implemented Gov. Mapp's plan in Act No.
9	7987, further amended by Act No. 8469, to repay public employees \$63 million for an eight
10	percent (8%) salary reduction implemented in 2011 by Act No. 7261 over a two year period
11	which was subsequently found, in 2016, to have violated the contract clause of the United
12	States Constitution by the United States Court of Appeals for the Third Circuit; and
13	WHEREAS, the Mapp-Potter administration paid refunds owed to taxpayers for tax
14	years 2010 through 2016, in excess of \$178 million; and
15	WHEREAS, Governor Kenneth E. Mapp and William J. Bratton, Police Commissioner
16	of the New York City Police Department (NYPD), formed an alliance between the Virgin
17	Islands Police Department (VIPD) and the NYPD to provide training and mentorship of VIPD
18	officers and supervisors at the New York City Police Academy; and
19	WHEREAS, the Mapp-Potter administration garnered full participation in the federal
20	Medicaid program for Virgin Islands residents who did not have health insurance, providing
21	vital healthcare services to many families; and
22	WHEREAS, in September 2017, the Virgin Islands experienced two of the Atlantic's
23	most destructive category 5 Hurricanes, named Irma and Maria, which barreled across the
24	Territory within fourteen days, disrupting the economy, and causing catastrophic damages to
25	homes, businesses, and the islands' infrastructure; and

1	WHEREAS, in October 2017, facing the devastation, Governor Kenneth E. Mapp
2	created a 20-member USVI Hurricane Recovery and Resilience Task Force noting, "this crisis
3	has afforded us the opportunity to build our communities better and stronger than ever"; and
4	WHEREAS, the taskforce included territorial agency heads, senators, federal partners,
5	business leaders, nonprofit and inter faith community leaders and subject matter experts and
6	published a final report in 2018; and
7	WHEREAS, the taskforce report formed the blueprint for the Mapp-Potter
8	Administration as its path for the recovery and future protection of the Virgin Islands; and
9	WHEREAS, Governor Kenneth E. Mapp launched a national campaign to aid in the
10	rebuilding of the territory, the campaign included the President and Vice President of the
11	United States, Members of Congress, Governors, philanthropic organizations, and national
12	conglomerates; and
13	WHEREAS, Governor Kenneth E. Mapp, Lieutenant Governor Osbert E. Potter and the
14	Virgin Islands Delegate to Congress hosted visits to the territory of Vice President Mike Pence,
15	heads of federal agencies/departments, and Members of Congress; and
16	WHEREAS, Governor Kenneth E. Mapp and Lieutenant Governor Osbert E. Potter
17	hosted former United States President William "Bill" Clinton and the Clinton Global Initiative,
18	former New York City Mayor Michael Bloomberg and the Bloomberg Philanthropies, Mr.
19	Kenny Chesney, a homeowner on St. John and the Kenny Chesney Foundation Governors
20	Andrew Cuomo of New York, Chris Christie of New Jersey and Larry Hogan of Maryland and
21	Chairman of the National Governors Association, all of whom donated tremendous time,
22	money, expertise, resources, goodwill, and advice towards the Virgin Islands recovery; and
23	WHEREAS, Governor Kenneth E. Mapp with bipartisan support, successfully
24	persuaded Congress to adopt a number of unprecedented amendments to the Stafford Act, most

1 importantly, authorizing the federal government to invest in strengthening infrastructure to 2 withstand future disasters as opposed to rebuilding to an "as was" condition; and 3 WHEREAS, Congress authorized over \$9 billion to provide for the needs of the Virgin 4 Islands, operating bridge financing for the territorial government and its instrumentalities and 5 funds to rebuild its infrastructure, including but not limited to schools, hospitals, senior assisted 6 and long-term living facilities, electric production and distribution, airport improvements, 7 dredging of harbors, upgrading docks and bulkheads, road construction and repairs, hardening 8 telecommunication systems, and home and roof repairs; and 9 WHEREAS, pursuant to an Act of Congress and a historic first, the federal government 10 assumed 100% of the cost of the Virgin Islands Medicaid program for two years, which 11 provided much needed revenues to the territorial hospitals and healthcare system; and 12 WHEREAS, major capital projects completed during Governor Kenneth E. Mapp's 13 tenure included the Veteran's Drive Improvement Project, the bridge at Estate Nadir, known 14 as the "bridge to nowhere" on Turpentine Road, and the construction of the Downtown 15 Revitalization Project on Main Street in Charlotte Amalie; and 16 WHEREAS, Governor Kenneth E. Mapp, the President of the University of the Virgin 17 Islands, and the Chairperson of the University's Board of Trustees jointly announced a plan to 18 provide free tuition to territorial high school graduates to attend the University of the Virgin 19 Islands. Governor Mapp signed legislation into law providing such free tuition in 2018; and 20 WHEREAS, on January 7, 2019, Gov. Kenneth E. Mapp retired from Government after 21 providing more than 40 years of public service to the people of the Virgin Islands of the United 22 States; Now, Therefore, 23 Be it enacted by the Legislature of the Virgin Islands: 24 **SECTION 1.** The Legislature of the Virgin Islands, on behalf of the people of the Virgin 25 Islands, expresses its heartfelt thanks and appreciation to Governor Kenneth E. Mapp, eighth

- 1 elected Governor of the Virgin Islands for his dedication, commitment, leadership,
- 2 contributions, and outstanding public service of over 40 years.
- 3 **SECTION 2.** In recognition and appreciation of his contributions over a life of public
- 4 service, the Legislature hereby names Route 75, also known as Northside Road, on the
- 5 island of St. Croix, beginning at the intersection at Basin Triangle and Route 70 in Estate
- 6 Richmond through the northside of St. Croix and ending at Krausses Lagune, the "Gov.
- 7 Kenneth E. Mapp Highway".
- 8 **SECTION 3.** The Virgin Islands Department of Public Works shall cause signage to be
- 9 placed at major intersections along Route 75, including, but not limited to the intersection at
- 10 Bassin Triangle traffic light and Route 70, the intersection in Golden Rock at Route 703, the
- 11 intersection known as Five Corners at Rattan Road at Route 74, the intersection known as
- 12 Claude A. "Bennie" Benjamin Memory Drive, Route 79, the intersection known as the Sidney
- Lee/Northshore Rd Route 80, the intersection at Midland Road, Route 72, the intersection at
- Queen Mary Highway, Route 70 and at the intersection at Melvin Evans Highway, Route 66.
- 15 **SECTION 4.** The signage required by section 3 of this Act shall conform to the
- 16 guidelines of the United States Department of Transportation, Federal Highway
- 17 Administration's Manual of Uniform Traffic Control Devices bearing the inscription "Gov.
- 18 Kenneth E. Mapp Highway".
- 19 **SECTION 5.** (a) The sum of \$45,000 is appropriated to the Department of Public Works
- from the General Fund of the Treasury of the Government of the Virgin Islands, in the fiscal
- year ending September 30, 2024, to carry out the provisions of section 3 and section 4.
- 22 (b) The funds appropriated remains available until expended.
- 23 **SECTION 6.** In continued recognition and appreciation of his contributions and service,
- 24 the Legislature also confers the Virgin Islands Medal of Honor on the Eighth elected Governor
- of the Virgin Islands, Kenneth Ezra Mapp.

SECTION 7. The Virgin Islands Medal of Honor, cast in gold, together with a copy of this Act, shall be presented to Governor Kenneth Ezra Mapp by the President of the Legislature, or his designee, at an appropriate ceremony to be held for that purpose.

BILL SUMMARY

This bill commends Governor Kenneth Ezra Mapp for his years of service to the people of the Virgin Islands and names Route 75 on the island of St. Croix, starting at the Bassin Triangle traffic light in Estate Richmond and ending at Krausses Lagune, the "Gov. Kenneth E. Mapp Highway" in his honor. The bill recognizes several of Governor Mapp's major achievements, which are not all inclusive, and appropriates the sum of \$45,000 from the General Fund of the Treasury of the Government of the Virgin Islands to the Virgin Islands Department of Public Works to carry out the provisions of this Act. The bill further confers the Virgin Islands Medal of Honor on Kenneth Ezra Mapp for his commitment, service, and dedication to the people of the territory.
