An act amending Act No. 9035 by redesignating the funding source for several entities and correcting a typographical error and amending Act No. 9045 by inserting and striking appropriations

PROPOSED BY: Senator Kurt A. Vialet

Be it enacted by the Legislature of the Virgin Islands:

SECTION 1. Act No. 9035 is amended as follows:

(a) In in Section 1, Item T by inserting an “*” after “IAA ATHLETIC PROGRAM” and “INTERSCHOLASTIC SPORTS”; and

(b) in C/CNTR MISCELLANEOUS ORGANIZATIONS FY 2026 as follows:

(1) By inserting after “DHS YOUTH ARISE, INC* \$5,000” the following:

8	DOA R.E.A.L. Cats Spay/Neuter Program	\$ 22,500
9	DOA RUFF Start Spay/Neuter Program	\$ 22,500

1 (2) DOE ST CROIX SCIENCE TEACHERS FARM is amended by striking
2 “FARM” and inserting “ASSOCIATION”; and

3 (3) by inserting an “*” after “DOH MIH PROGRAM” and “JFLH CASA DE
4 SALUD”.

5 (c) On page 13, in “ORG 800 DEPARTMENT OF PLANNING AND NATURAL
6 RESOURCES”:

7 (1) Insert the following line item after “UTILITIES”:

8 “DIVISION OF PERMITS PERSONNEL \$600,000”;

9 (2) Strike \$6,068,164” and insert “6,668,164”; and

10 (3) Strike “7,009,487” and insert “7,609,487”.

11 (d) On page 15, in “SUB-TOTAL GENERAL FUND”, strike “\$684,841,974” and
12 insert “\$685,441,974”; and

13 (e) On page 15, in “GRAND TOTAL GENERAL FUND”, strike “\$738,601,274” and
14 insert “\$739,201,274”.

15 **SECTION 2.** Act No. 9045 is amended as follows:

16 (1) by striking “\$6,074,209” and inserting “\$5,509,209”;

17 (2) by inserting “Section 1, Item T, ORG 400 DEPARTMENT OF EDUCATION and”
18 after “through”;

19 (3) by inserting an “*” after “IAA ATHLETIC PROGRAM” and
20 “INTERSCHOLASTIC SPORTS”; and

21 (4) by striking the following:

22 DOA HUMANE SOCIETY STT*

23 DOA R.E.A.L CATS SPAY/NEUTER PROGRAM*

24 DOA RUFF START SPAY/NEUTER PROGRAM*

25 DOA ST CROIX ANIMAL WELFARE CENTER SPAY/NEUTER PROGRAM*
