An Act approving a multi-year lease agreement between the Government of the Virgin Islands, acting through its Commissioner of the Department of Property and Procurement, and U.S.V.I. Soccer Federation, Inc., for Parcel N-1-Remainder of Tract 1 Estate Nazareth, No.1 Red Hook Quarter, St. Thomas, Virgin Islands, for a soccer field stadium with concessions, and soccer-related activities

PROPOSED BY: Senators Novelle. E. Francis, Jr., and Dwayne M. DeGraff by Request of the Governor 1 WHEREAS, on September 23, 2024, the Governor of the Virgin Islands approved the 2 lease agreement between the Government of the Virgin Islands and U.S.V.I. Soccer Federation, 3 Inc.; 4 WHEREAS, U.S.V.I. Soccer Federation, Inc., is leasing Parcel N-1-Remainder of Tract 5 1 Estate Nazareth, No.1 Red Hook Quarter, St. Thomas, Virgin Islands, consisting of 6 219,193.92 U.S. sq. ft. or 5.032 U.S. acres, more-or-less, of unimproved land, as shown on 7 O.L.G No. D9-9848-T024, dated May 7, 2024, to be used for a soccer field stadium with 8 concessions, and soccer-related activities; 9 WHEREAS, the premises is leased for an initial term of 30 years, with two options to 10 renew for two additional terms of 10 years each: 11 WHEREAS, the rent will be \$3,600 per annum, payable in equal monthly installments 12 of \$300; and

2	provides that in addition to the Governor's approval of any lease, the Legislature of the Virgin
3	Islands must approve all leases exceeding a term of one year; Now, Therefore,
4	Be it enacted by the Legislature of the Virgin Islands:
5	SECTION 1. Pursuant to title 31 Virgin Islands Code, section 205, subsection (c), the
6	Legislature of the Virgin Islands approves the lease agreement between the Government of the
7	Virgin Islands, acting through its Commissioner of the Virgin Islands Department of Property
8	and Procurement and U.S.V.I. Soccer Federation, Inc., for Parcel N-1-Remainder of Tract 1
9	Estate Nazareth, No.1 Red Hook Quarter, St. Thomas, Virgin Islands, consisting of 219,193.92
10	U.S. sq. ft. or 5.032 U.S. acres, more-or-less, of unimproved land, as shown on O.L.G No. D9-
11	9848-T024, dated May 7, 2024, for a term of 30 years with two options to renew for two
12	additional terms of 10 years each with an annual rent of \$3,600, to be used for a soccer field
13	stadium with concessions, and soccer-related activities.
