

WARRANTY DEED

WITNESSETH that in consideration of Ten Dollars (\$10.00) and other good and valuable consideration to it in hand paid, receipt of which is hereby acknowledged, Grantor does hereby grant and convey unto Grantee, its successors and assigns, all the following described real property situated in St. Croix, U.S. Virgin Islands, to wit:

Plot No. 36 (0.11 U.S. acre) and Plot No. 37 (0.11 U.S. acre) Estate Richmond, of Subdivision of Parcel 11, Matr. No. 1AL, Company Quarter, St. Croix, U.S. Virgin Islands, as more fully shown on OLG Drawing No. 103, dated July 07, 1945:

TOGETHER with all the tenements, hereditaments, buildings, and appurtenances thereunto belonging.

SUBJECT, HOWEVER, to all restrictions and covenants of public record.






