As the authorized agent representative for Mr. Misbeh in this matter, I respectfully request an amendment to the Official Zoning Map No. SCZ-7 for St. Croix, changing the zoning designation of the property from R-1 (Residential-Low density) to B-2 (Business – Secondary/Neighborhood).
